# 1. Curtin Place Sewerage Issue

Problems have been experienced with sewer surcharge from a manhole located at the intersection of Enfield Ave and Curtin Place. Council is looking to remove loading from the line to help alleviate the issue but long-term solutions are still being reviewed.

# ITEM: 5 PROPOSAL TO TRANSFER ROAD MANAGEMENT

#### **SUMMARY**

Advice was received 12 September 2017 from Pikes & Verekers Lawyers in regards to the proposal to transfer road management functions of Hughes Lane, Marrangaroo from the Crown to Council.

The Depart of Industry – Lands and Forestry Division has advised Council that it proposes to take steps to have Council assume responsibility for Hughes Lane. At present the relevant portion of Hughes Lane is a Crown road.

Council is opposed to the transfer of responsibility for Hughes Lane to Council because its need for capital works and thereafter its upkeep will place an unreasonable impost upon Council and its ratepayers.

Pikes & Verekers Lawyers advised that 'assuming that the correct head of power is used and the reference is to the correct Minister then it may be difficult for Council to challenge the transfer. Section 151(3) of the Roads Act makes it plain that, except for the RMS, no other roads authority is required to consent to a transfer of responsibility to it.'

It was then advised that 'there are the usual protections of administrative law i.e. Council needs to be given proper notice of the proposal, the opportunity to make submissions in respect of it and the determination has to be made by the Minister having regard to the appropriate considerations and no others.'

# SUMMARY

Correspondence has been received from the Hon. Darren Chester MP, Minister for Infrastructure and Transport in regard to the Roads to Recovery (R2R) Program. The Minister has issued a Statement of Expectations for the program and is to bring R2R in line with other Australian Government programs where funding is issued with a set of expectations.

The statement asks councils to consider directing more of their R2R funding to projects that are likely to reduce fatalities and serious injuries in crashes and to work with the Infrastructure and Transport Department to improve the reporting of safety and other outcomes from the R2R Program. A more formal evaluation by councils R2R projects will also make it easier for the Infrastructure and Transport Department to show how they have benefitted the local network and the community.

The Hon. Darren Chester MP has invited councils to write to him with ideas of how all levels of government could be improving road safety and the outcomes from the considerable investment everyone makes in the country's roads.
