APPLICATION CONDITIONS

Location details:

To be eligible for the rebate you must be a ratepayer in the Lithgow Local Government Area and the property must be located in the village areas of Lithgow, Portland, Wallerawang, Lidsdale or Rydal.

Residents in rental properties can apply for incentives provided that the tenant and the property owners agree and both sign the application.

All coal heaters must be removed and only one cash incentive is available for each premises.

Eligible systems:

A rebate is only available for the replacement of coal heaters.

Both electric and gas heaters are eligible for a \$1,000 rebate (\$1,400 rebate for pensioners) and \$2,000 for Commercial premises.

Installation and disposal:

The replacement heating system must be installed in the same property as the heating system being replaced.

The coal heater must be removed and deposited at the Lithgow Solid Waste Facility for metal recycling. For an open fireplace, the recipient must insert a replacement heater into the fireplace or permanently disable the fireplace to the satisfaction of Council.

Required standards:

Replacement systems, their installation and operation must comply with all relevant Australian Standards, building codes, local government requirements and the manufacturer's recommendations.

No retrospective incentives:

If you have already replaced or are in the process of replacing an eligible coal heater, you are not eligible for a rebate, unless the coal heater/s is/are still installed.
