


- Just beautiful and worth preserving.

- Good use.




- Encourage education it is our future.


- God awful. Change to light industry.

- The lifeblood of our community




- Needs attention.

- Bulldoze it




- NIMBY.

- Fine in selected areas. Reality is that wind farming is virtually all overseas owned and developed. Australia missed the boat.




