ITEM: 4 RURAL AND RURAL RESIDENTIAL STRATEGY REVIEW – PROJECT UPDATE

SUMMARY

Council's consultant Mr Ian Sinclair has continued work on the project during the months of December and January.

A brief update of the following tasks was provided to, and discussed with, the Committee. The Committee was advised that some of this analysis is in preliminary form and will be further refined and checked as the project progresses:

Key Stakeholder Meetings: Meeting of key rural and resource sectors were held on 3 and 4 December 2015. These meetings provided good feedback in relation to rural values, concerns and the current and future situations for the resource sectors of mining and energy.

Demographic Analysis. Detailed analysis has been carried out of the demography of the rural land. This has been done at the Statistical Area Level 1 (former Collector District) of which there are 20 (these have been determined by the Australian Bureau of Statistics). This has enabled comparisons to be done for the rural areas, urban areas and the Lithgow LGA as well as Sydney, NSW and Australia. Topics covered include population (males, females and persons), occupancy rate, age of the residents, volunteering, internet usage, industry of workforce, qualification and working from home.

Economic Analysis. Analysis has been carried out using the ABS Agriculture Census value of production and commodities produced. This has been analysed to provide comparisons to the Central West Region, NSW and Australia for a range of agricultural commodities. In the case of Lithgow, the total value of production is \$18.8million, of which half (\$9 million) is cattle and egg production is valued at \$4.7 million.

Social and Physical Infrastructure. Data on the social and physical infrastructure is to be compiled in tabular format to provide an appreciation of the level of infrastructure in the rural areas.

Rural Holdings. The rural holdings have been mapped and the map and the range of holdings were presented and discussed.

Rural Residential Land Use Criteria. A set of land use criteria has been developed for identifying land for future rural residential development based on experience of other similar areas. This criteria is to be included in the rural residential discussion paper and used at the rural residential workshop to inform discussion.

Rural Residential Discussion Paper. A discussion paper is to be prepared on rural residential development in advance of the workshop on the 22 February 2016. This discussion paper will define rural residential development and discuss some of the issues pertaining to rural residential land use. It is intended to be generic in focus with some local examples where appropriate.

Overview of proposed facilitation of February workshops. Interest in the visioning workshops has been very strong indicated through on line registration of

participants. An additional workshop has been arranged for Hartley in the afternoon of 11 February commencing at 2pm to accommodate the overwhelming demand.

The high number of participants will be taken into consideration in the facilitation of the workshops.
