# 4. Staff and Police Reports

# 4.1 Bureau of Crime Statistics Quarterly Report of Recorded Crime Statistics dated March 2022

#### **Summary**

A summary of the Bureau of Crime Statistics Quarterly Report of Recorded Crime Statistics dated March 2022 was discussed.

#### Commentary

The Bureau of Crime Statistics Quarterly Report of Recorded Crime Statistics dated March 2022 shows the following data on Lithgow Crime Incidents:

# 1. Trends in recorded Criminal Incidents in Lithgow LGA for major offences over the 24 months to March 2022

There were no significant trends in Lithgow crime rates during the reporting period.

# 2. Ratio to NSW rate (per 100,000 population) of recorded criminal incidents for 12 months to March 2022.

- Lithgow rates of sexual assault were 2.1 times the NSW rate.
- Lithgow rates of sexual touching and other sexual offences were 1.8 times the NSW rate.
- Lithgow rates of Domestic Violence related assault were 1.8 times the NSW rate
- Lithgow rates of Non- Domestic Violence related assault were 1.6 times the NSW rate
- Lithgow rates of other stealing offences were 1.9 times the NSW rate.

# 3. Number of recorded criminal incidents in Lithgow LGA for major offences over 12 months to March 2022 and to March 2021.

#### **Police Comments**

The Police representatives advised that Assault (Non- Domestic Violence Related) incidents include school assaults which are often referred to Police whereas in the past they were often dealt with by the schools.

There have been a considerable number of driving offences around schools.

There has been no upward trend in rates of alcohol related violence

## Summary

The Police representatives provided a report on local crime and Policing matters.

### Commentary

This data shows no significant trends compared to 2021. The Police representatives advised that in general there are no major areas of concern with crime rates in the Lithgow area. Phone scams targeting the elderly continue to be a concern. Senior Constable Arna Martin provided some Fact sheets for Council to promote, on how people can avoid these scams.

There was a discussion on the increased number of homeless people living in and around Lithgow including the CBD. This is a widespread issue across Australia, linked in part to rising rental and housing costs. The Police have been in regular touch with a number of local homeless people as well as local business owners regarding this issue however the Police have limited powers to move people on unless they are committing an offence.

Council has initiated the establishment of an interagency of organisations that works with homeless people to identify options for addressing the homeless issue. The reality is that some people are choosing to live on the street in preference to taking up housing options. Council will follow up on options for addressing community concerns around a homeless person living in Cook street Plaza.
