4. Declaration of Interest

5. Presentations

5.1. Presentation by Carl Solomon – Destination Marketing Store

The committee introduced themselves, who they represent and what they wish to achieve from this committee and tourism in the Seven Valleys area.

Destination Marketing Store (DMS) presented an action plan and strategic direction for the Destination Management Plan (DMP).

It was asked if there was a timeline for the document and how the feedback process will work. DMS advised that a project plan and timeline will be provided to the committee outlining the process. This committee and DMP is the beginning of the journey.

It was asked what methods of engagement will be used as there are a diverse range of communities in the LGA. DMS advised that a mix of approaches will be used including workshops with the different industries, one-on-one's or small group meetings, meeting First Nations people on their land and to do most sessions face-to-face. Information that requires feedback from the committee will be sent through prior to the next committee meeting to be discussed or information will be provided as an agenda item at the meeting and for feedback to be given the week after.

It was asked if the consultation process will be similar with the consultation for Destination Network Central West NSW. It was advised that improvements have been made since that consultation and that the DMP will be specific in Lithgow. As Lithgow is situated between the Central West and the Blue Mountains, the DMP will be carefully designed to suit the Seven Valleys tourism area. Seven Valleys has assets that are unique to Seven Valleys and with the help of this committee and developing the DMP, points of difference can be identified, while also working collaboratively with the surrounding regions and utilising the knowledge of the committee to achieve success. At present Seven Valleys does struggle with attracting tourism to the area, for long term Lithgow in particular to be more than just a through town.

6. Reports

6.1. Zig Zag Railway Update – Daniel Zolfel

D Zolfel provided an update on Zig Zag Railway. He advised that Zig Zag is back and will publicly announcing the opening weekend at a media event this weekend. Opening will be very soon for Winter, operating times will be every second weekend with 3 sessions a day accommodating 900 passengers and a new cafe will open in the precinct. D Zolfel advised that the opening isn't the finish line but the beginning with ideas for hosting events, exhibitions and markets in the future.

Zig Zag wants to ensure that they are firmly associated with the Seven Valleys and to work alongside and in partnership with the local attractions, accommodation and food in Lithgow. Comment was made that to help attract these visitors to come into Lithgow, shops and cafes need to be open. D Zolfel advised that he would like to have displays, banners and brochures for Lithgow businesses on display to encourage visitors to come into Lithgow and for local businesses to have the same for Zig Zag.

6.2. Gardens of Stone SCA Update

L Wallace provided a presentation on the scope of work for the Garden of Stones project. L Wallace advised that construction on some of the bike tracks will commence in September 2023 and sections of the campground areas will be open by December 2023.

It was asked how the issue of 4WD's and motor bikes entering from the Clarence entrance to the National Park near the Zig Zag Railway will be managed. L Wallace advised that data has been collected on all entrances into the park and a Road Access Strategy will be developed to help manage this issue. This strategy directs visitors to use the State Mine Gully entrance to the park.

NPWS encourages partnerships to be developed with local businesses to help champion Lithgow and to encourage visitors to stay in the Seven Valleys and use local businesses.
