# SUMMARY

To advise Council of the proposed Christmas in the park function to be held on 9 December 2017.

# COMMENTARY

Following the movement of Lithglo from December to a more appropriate time and location in 2018, it was always proposed to hold a Christmas event in Queen Elizabeth Park Lithgow to provide entertainment for the local community in the spirit of the upcoming festive season.

The structure of the event at this stage will involve afternoon markets in the park leading up to a Carols by Candlelight presented by the combined churches choir.

There is no set budget for the event at this stage. However it would be suggested that a small amount of funds be allocated to carry out the event and this be reflected in a budget adjustment in the March 2018 quarterly budget review.
