## Introduction

Lithgow City Council invited residents and community groups to put forward proposals to be considered for inclusion in the 2024/25 Draft Operational Plan. The community was encouraged to submit their proposals online via Council's Have Your Say portal [www.ourplaceourfuture.lithgow.com](http://www.ourplaceourfuture.lithgow.com) between 22 December 2023 and 15 February 2024. During that time over 80 proposals from residents and community groups across the LGA were received with some respondents providing multiple proposals.

The Council acknowledges and appreciates the community's contribution to the draft 2024/25 Operational Plan. All proposals were considered in accordance with budget availability, staff capacity and value to the community.

The proposals have been categorised into topics/localities, summarised and an officer's response has been provided for the information and consideration of Council and the community.

The project was designed and developed by Jessica Lawn a heritage garden consultant who made seasonal maintenance visits to work with volunteers. The design of the garden reimagines the layout and plantings of an 1800s kitchen garden. The EHM Heritage Garden continues to be developed by a small team of volunteers.</p> <p>Mary's Garden Team meet on Thursdays at EHM. 	<b>Intersection of Vale Street and Wolgan Street</b> – resheeting to enhance pedestrian safety and problems with kerb in front of school	Repair of the kerb in front of the Portland Central School was raised at a recent TALC meeting for repair under existing maintenance programs.
	Prepare treatment plan for cutting on <b>Barton Avenue Wallerawang</b> between James Pde and Lyon Pde with costings for future treatment/programs	<p>The possibility of reducing the grade of the bank on the southern side of Barton Avenue between Lyon Parade and James Street was investigated approximately 10 years ago. At that time, it was considered to be not cost effective due to the high costs of relocating the underlying assets.</p> <p>In this area, there is a water main, Endeavour Energy poles, a gravity sewer main and a pressurised sewer main. Each would be impacted by a reduction of grade or modifications to the embankment. There are also adjacent driveways that will need to be modified.</p> <p>In terms of crash statistics, there is no accident history in this location. The two recorded accidents in Wallerawang (since 2018) were a crash in 2019 at Blackberry Lane, and a crash in 2021 adjacent to the Wallerawang Public School.</p> <p>While the intersection isn't compliant for sight distance it is a difficult area to install improvements as it is in the base of a cutting already. Not impossible by any means, but it would result in what I expect to be approximately \$300 - \$500,000 of investment to make a real difference.</p> <p>At this time, noting the lack of accident history and the variety of other priorities through the region, this project is not considered a high priority.</p>
	Resealing of junction of <b>Boulder Road and Back Cullen Road</b>	Suggested for inclusion in the 2025/26 Operational Plan
One	<b>State Mine Gully Road</b> has desperately needed a renewal upgrade for decades now as it is mostly patches on patches on patches etc. Also, in conjunction with a new road storm water drains need to be included as the runoff from rains currently drain all over the road flooding it and	This work has been scoped for inclusion as part of the broader Gardens of Stone development as the asset will require upgrade prior to the delivery of this project. The project has been costed at approximately \$4 million. Council continues to advocate for external State Government funding from the \$50M allocated to Gardens of Stone to deliver this project.

There are currently small sections of the road that do not need repairs; however, edges are beginning to break away which will cause issues in the near future. Drainage needs to be improved so water can get off the road and into drains rather than sitting on the road surface and penetrating the surface causing damage. There is being no preventative maintenance being undertaken!	Under the Disaster Recovery Funding Arrangements, \$420,000 has been applied for, to repair Portland Sunny Corner Road.
