- 1. **Approve**: extension of existing contracts/ engagements for enviro, constructability, estimating and risk to inform the funding application/ ROI/ RFT slide 6
 - (circa \$400k exc GST)
- 2. Approve: tranche 1 site investigations, Geotech, topographical and biodiversity survey slide 6
 - (circa \$1m exc GST)
- 3. Approve: engagement of property specialist, subject matter experts and asset management slide 6
 - (\$600k exc GST)
- 4. Approve: release ROI and subsequent RFT for Technical Advisor: CD&EA Services slides 5 & 6
 - (circa \$4.5m Exc GST)
- 5. Approve: release RFT for medium-term procurements to support the Technical Advisor: CD&EA slide 7
