I have taken some time to review Council's ongoing maintenance budget and as it stands, I am unable to locate available funding to assist you with your request. I've also searched Council's own records for agreements made by previous members of staff to this effect with no luck. For this reason, I unfortunately cannot approve your request for work on private property as at this point in time, Council is struggling to stretch its limited resources to its own core areas of responsibility in a manner that maintains levels of service within budgetary constraints.

However, I do understand your plight and the situation the Portland Golf Club is in with regard to resources. Therefore, I will be putting a report to Council outlining the issues at hand. This process will give the elected Council the opportunity to reallocate funding from another area should they determine your request to be a priority. I will inform you of the outcome once it has been determined.

Last week we met with Graeme Faulkner and Jonathon Edgecombe re assistance for Portland Golf Club.

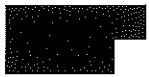
*Assistance in maintaining a storm water drain that collects water from the old Wang/Portland Road and drains into the club land (which is private land)

*Mowing the 2 banks adjacent to the car park using the Council's Articulated Arm Mower (a few times each year)
This has become a dangerous activity as the club age demographic increases.

In the past both Stuart McPherson and Roger Bailey have pledged \$10K "work in kind" to the club and the mowing has been done.

(An onsite inspection with Jonathon was not deemed successful.)

The club would like to see this pledge honoured and this work continued.
