Methodology and Sample

Sample selection and error

A total of 400 resident interviews were completed. Respondents were selected by means of a computer based random selection process using Australian marketing lists.

A sample size of 400 residents provides a maximum sampling error of plus or minus 4.9% at 95% confidence. This means that if the survey was replicated with a new universe of N=400 residents, 19 times out of 20 we would expect to see the same results, i.e. +/- 4.9%. For example, that an answer such as 'yes' (50%) to a question could vary from 45% to 55%.

Interviewing

Interviewing was conducted in accordance with The Research Society Code of Professional Behaviour.

Data analysis

The data within this report was analysed using Q Professional.

Within the report, blue and red font colours are used to identify statistically significant differences between groups, i.e., gender, age, etc.

Significance difference testing is a statistical test performed to evaluate the difference between two measurements. To identify the statistically significant differences between the groups of means, 'One-Way Anova tests' and 'Independent Samples T-tests' were used. 'Z Tests' were also used to determine statistically significant differences between column percentages.

Note: All percentages are calculated to the nearest whole number and therefore the total may not exactly equal 100%.

Ratings questions

The Unipolar Scale of 1 to 5 was used in all rating questions, where 1 was the lowest support or concern and 5 the highest support or concern.

Top 2 Box (T2B): refers to the aggregate percentage (%) score of the top two scores (i.e. agree and strongly agree, concerned and very concerned, etc.)



Research Objectives

Lithgow City Council commissioned Micromex Research to conduct a random telephone survey with residents living in the Lithgow City Council local government area (LGA).

Objectives (Why?)

- Understand and identify community priorities for the Lithgow LGA
- Identify the community's perceived quality of life
- Identify the community's level of agreement with statements regarding the Lithgow City Council area
- Gauge level of support towards a range of future Council projects and initiatives
- Understand the community's level of concern and preparedness for shocks and stressors

Sample (How?)

- Telephone survey (landline N=67 and mobile N=333) to N=400 residents
- We use a 5-point scale (e.g. 1 = not at all concerned, 5 = very concerned)
- Greatest margin of error +/- 4.9%

Timing (When?)

- Implementation 16th – 23rd September 2024

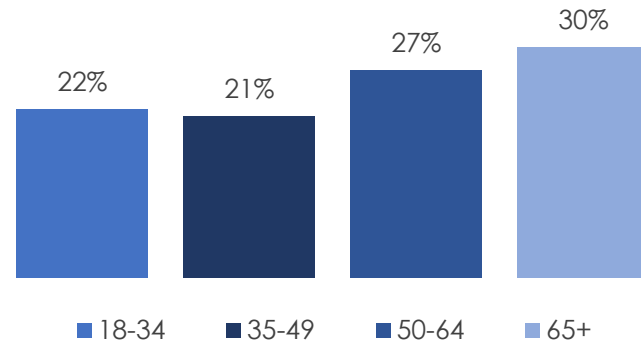

The sample was weighted by age and gender to reflect the 2021 ABS Census data for the Lithgow City Council area.

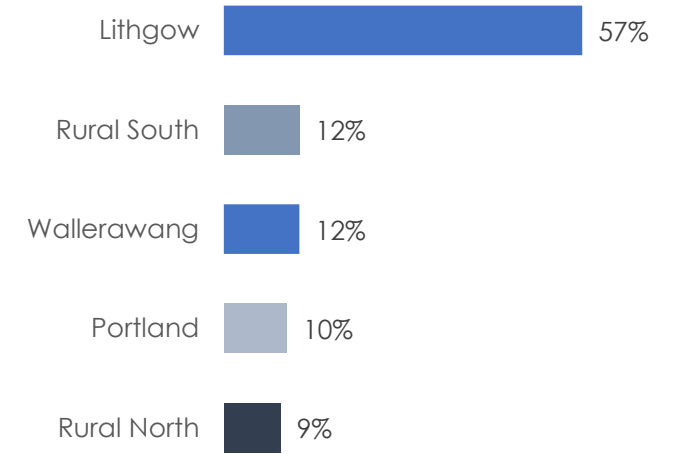

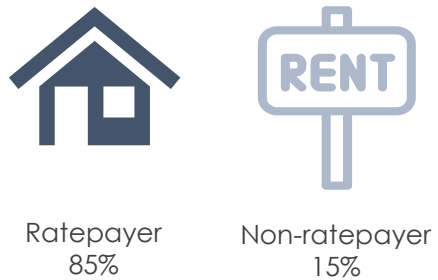

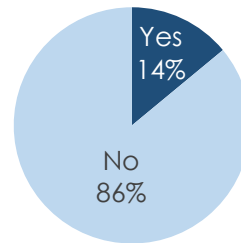

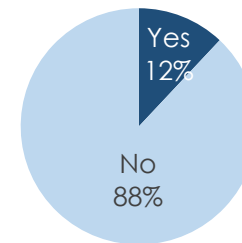

Do you identify as living with disability?



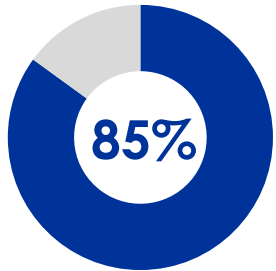

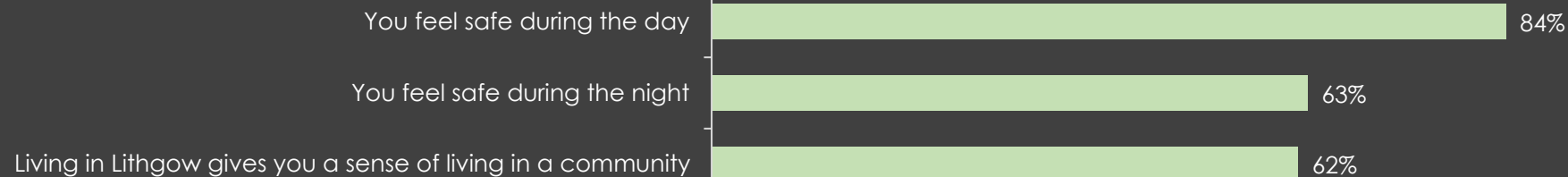

Key Themes

Community Sentiment



Overall quality of life in Lithgow is high, with 85% rating it as good to excellent. Residents particularly value the sense of community, natural environment, convenient location, and relaxed lifestyle. However, there are growing concerns about economic development, infrastructure, and Council planning/management.

Economic Development and Employment



This emerged as the top priority issue, with 58% mentioning it as the highest priority for the next 10 years. There is very low levels of agreement with economic development measures and current job opportunities, especially for youth. Only 13% agree there is a wide range of work opportunities locally, and just 8% believe young people are likely to get a quality local job in the future. There is strong support (91%) for developing more employment opportunities for young families and attracting larger retailers to the area (84%).

Planning and Communication



There is low agreement with Council's performance in several areas. Only 15% feel that information about Council decisions is clear and accessible and just 10% believe Council adequately considers community concerns in decision-making. Only 9% agree Council plans well for the long-term future. This suggests a need for improved transparency and community engagement in planning.

Infrastructure and Services



Roads and infrastructure are a concern to residents, with 32% wanting to see changes in road upgrades and maintenance. Only 19% agree that roads are safe for motorists. There are also large concerns about demands on health services, with 76% concerned/ very concerned about this issue. Support is high for increased aged care services (87%), developing more education opportunities for young families (86%), improved health services access (84%) and increased youth services (84%).

The key findings from the community research highlight the desire for balanced growth that preserves Lithgow's natural assets and community feel, while addressing challenges in terms of economic growth and infrastructure. Improving Council communication/engagement and youth opportunities have emerged as key areas for focus.

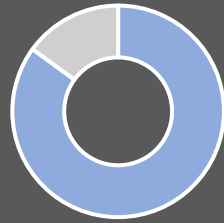


Living in the Lithgow LGA

Summary: Living in the Lithgow LGA



85% of residents rated their **quality of life** as 'good' to 'excellent'.

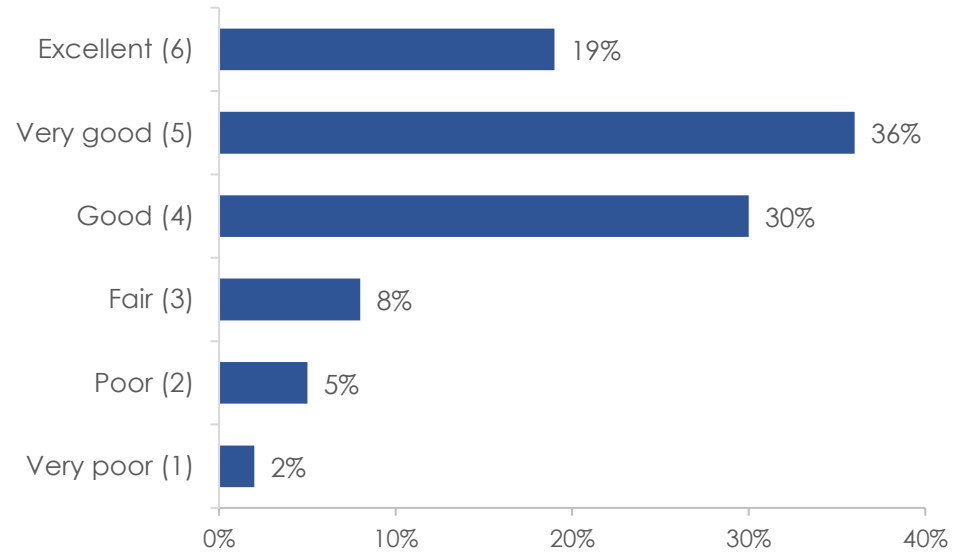
Sense of community and cost of living has the greatest influence on quality of life in the area (see slide 24).

- **Agreement statements**
 - Agreement was highest overall for safety in the LGA during the day, with 84% in agreement.
 - 68% or more disagree/strongly disagree with the statements; Council adequately considers community concerns and views in making decisions (73%), Council is focused on the future and plans well to help secure the community's long term future (71%), There is sufficient planning for local economic growth and development (71%), the local economy is ready for the future (70%), the Lithgow Council encourages and supports a diverse range of industries and businesses (68%) and young people are likely to get a local, quality job in the future (68%).
 - Compared to the Micromex LGA Benchmark there was higher agreement (9% higher) for responsiveness of Police and lower agreement (20% or more lower) for clear and accessible information, new developments (preservation of landscape and heritage), shops and services, future planning and leisure/recreation opportunities.

Quality of Life

Overall, 85% of residents rated their quality of life living in the Lithgow City Council area as 'good' to 'excellent'.

Lower quality of life ratings was seen for those aged 18-34 and those living with disability. Higher ratings was seen for those aged 65+ and those living in the Rural South and Rural North.

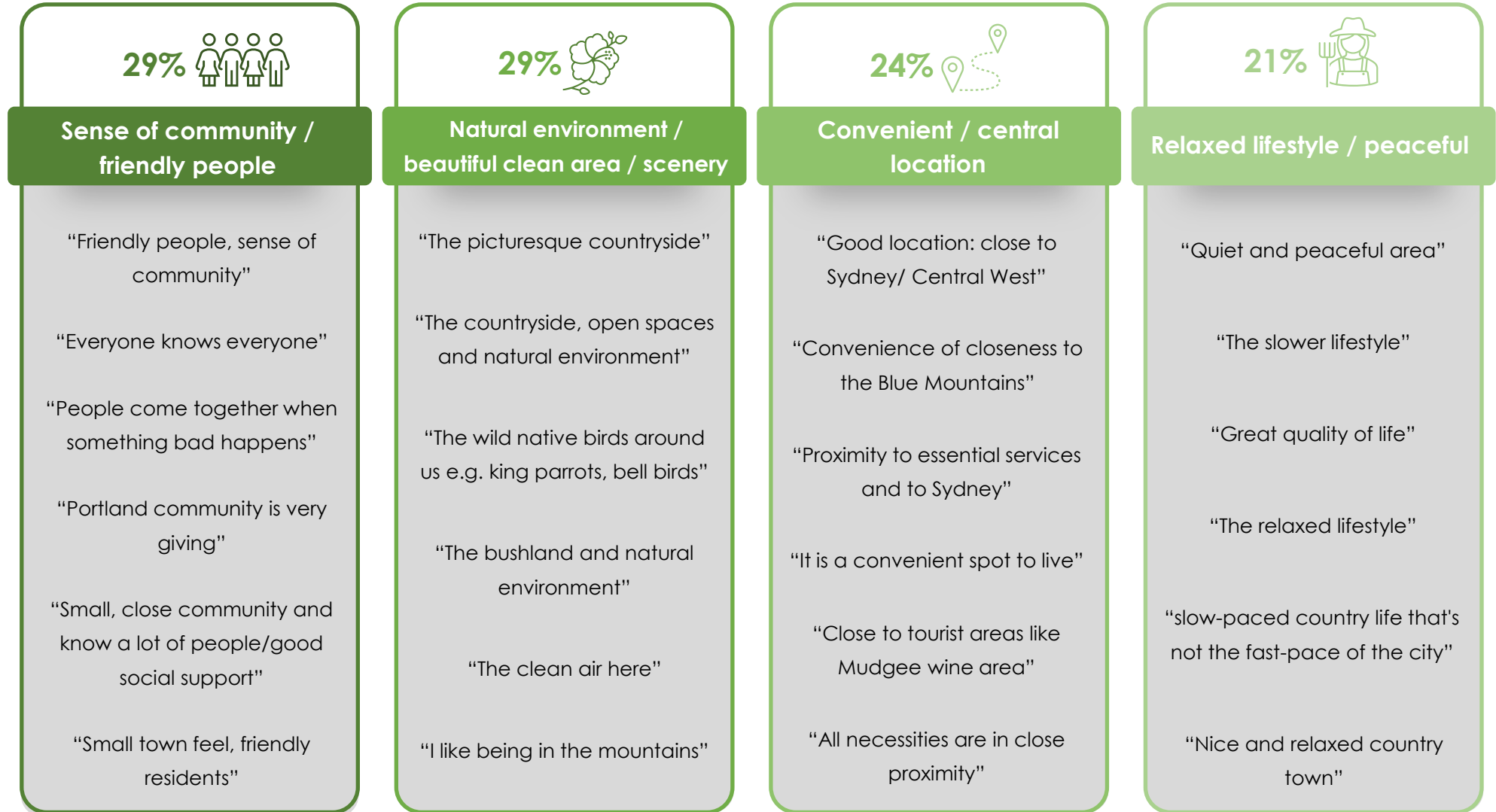

Most Loved Aspects of Living in the Lithgow LGA

When asked about the most loved aspects of the Lithgow LGA, 29% of residents mentioned the community and the environment.

Further, 24% stated they love the location, and 21% mentioned the relaxed lifestyle of the area.

The community and the environment remain the most loved aspects of living in the Lithgow LGA.

Compared to 2021 significantly more residents stated they love the location, sports and recreational activities and the ease of movement.

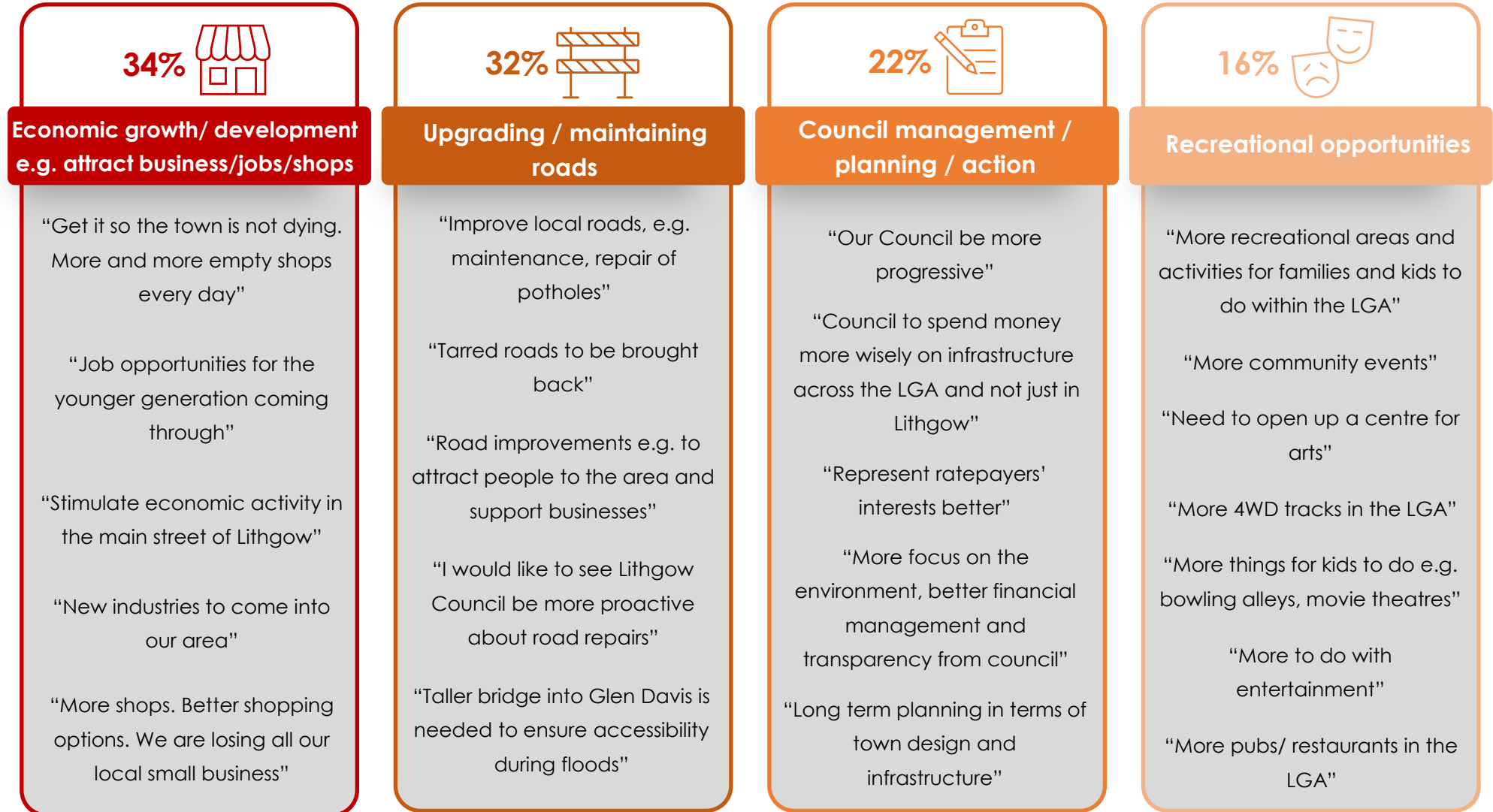

What Could be Changed about Living in the Lithgow LGA

34% would like to see change in the economic development of the LGA with mentions of having more job opportunities and attracting more businesses and shops. 32% mentioned roads.

Other priority areas include Council management/ planning (22%) and more recreational opportunities (16%).

Residents continue to predominantly want to see changes to the Lithgow economy and roads.

Compared to 2021 significantly more residents would like to see changes in Council management, planning and action and cost of living/rates.

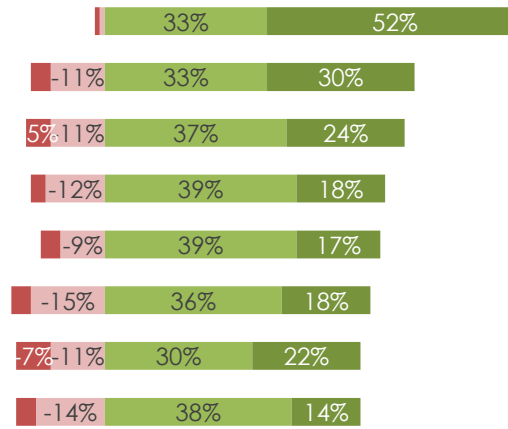

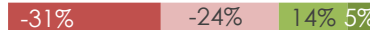

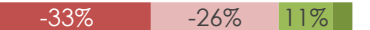
Lowest Level of Agreement (B2B)

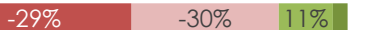

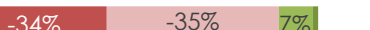

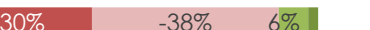

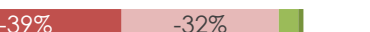

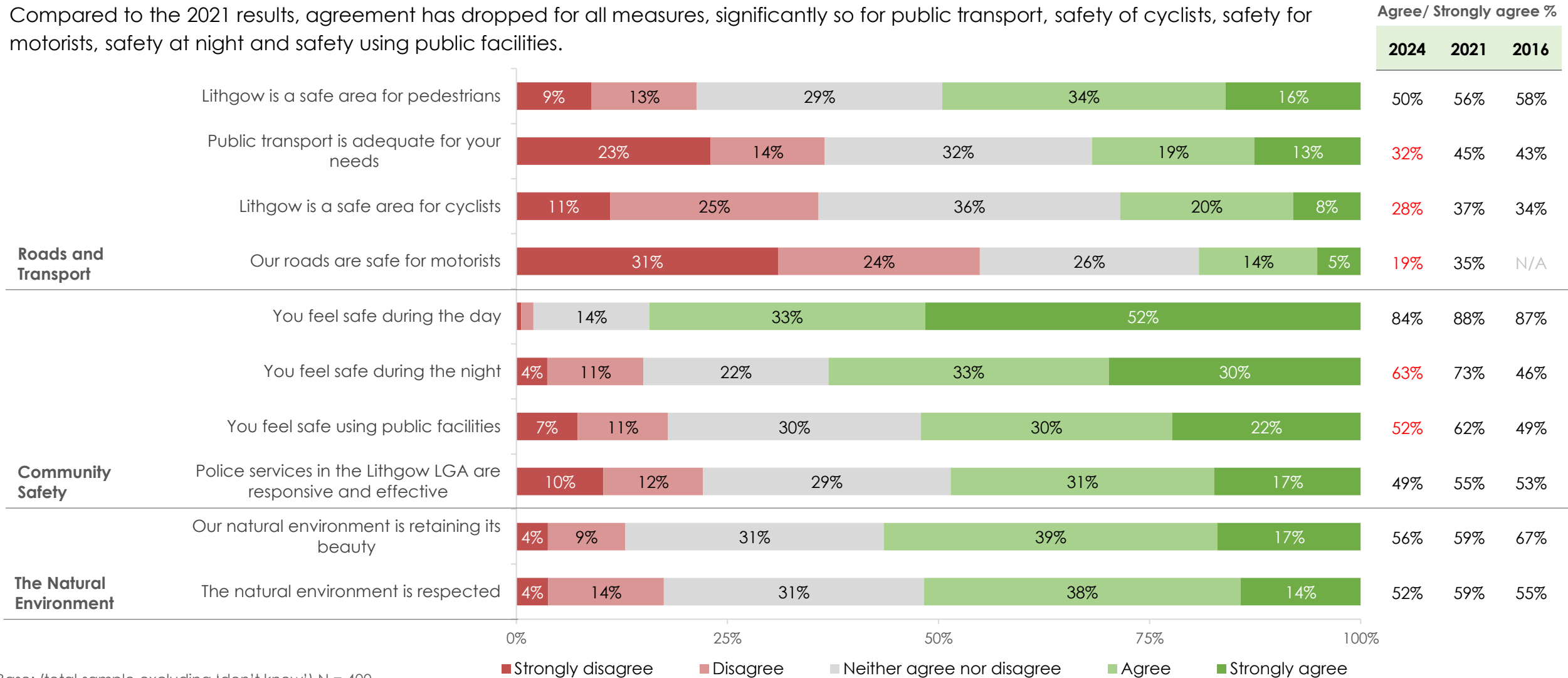

Agreement with Liveability Statements

84% of residents agree with the statement 'you feel safe during the day', whilst 55% disagree with the statement 'our roads are safe for motorists'.

Compared to the 2021 results, agreement has dropped for all measures, significantly so for public transport, safety of cyclists, safety for motorists, safety at night and safety using public facilities.

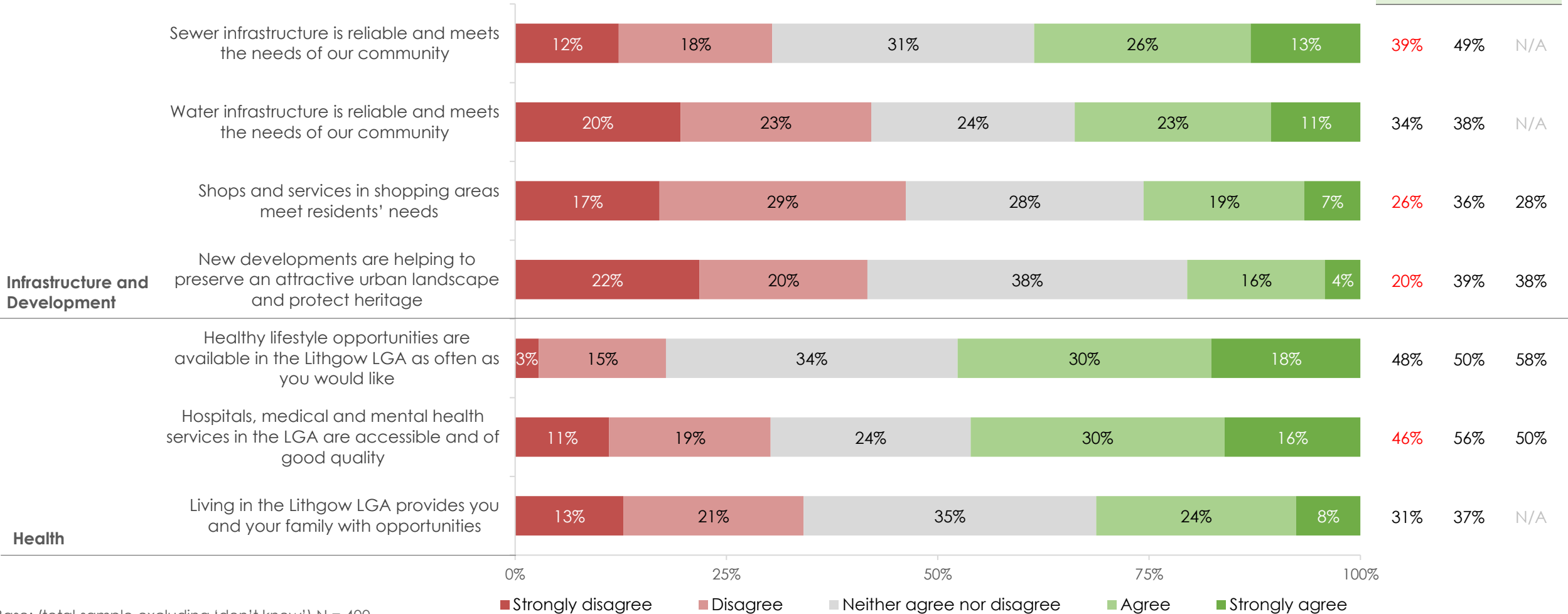
Agreement with Liveability Statements

Compared to the 2021 results, agreement has dropped for all measures, significantly so for sewer infrastructure, shopping and new developments preserving urban landscape and heritage.

Agreement with the reliability of sewer infrastructure is significantly lower for those residing in Rural South.

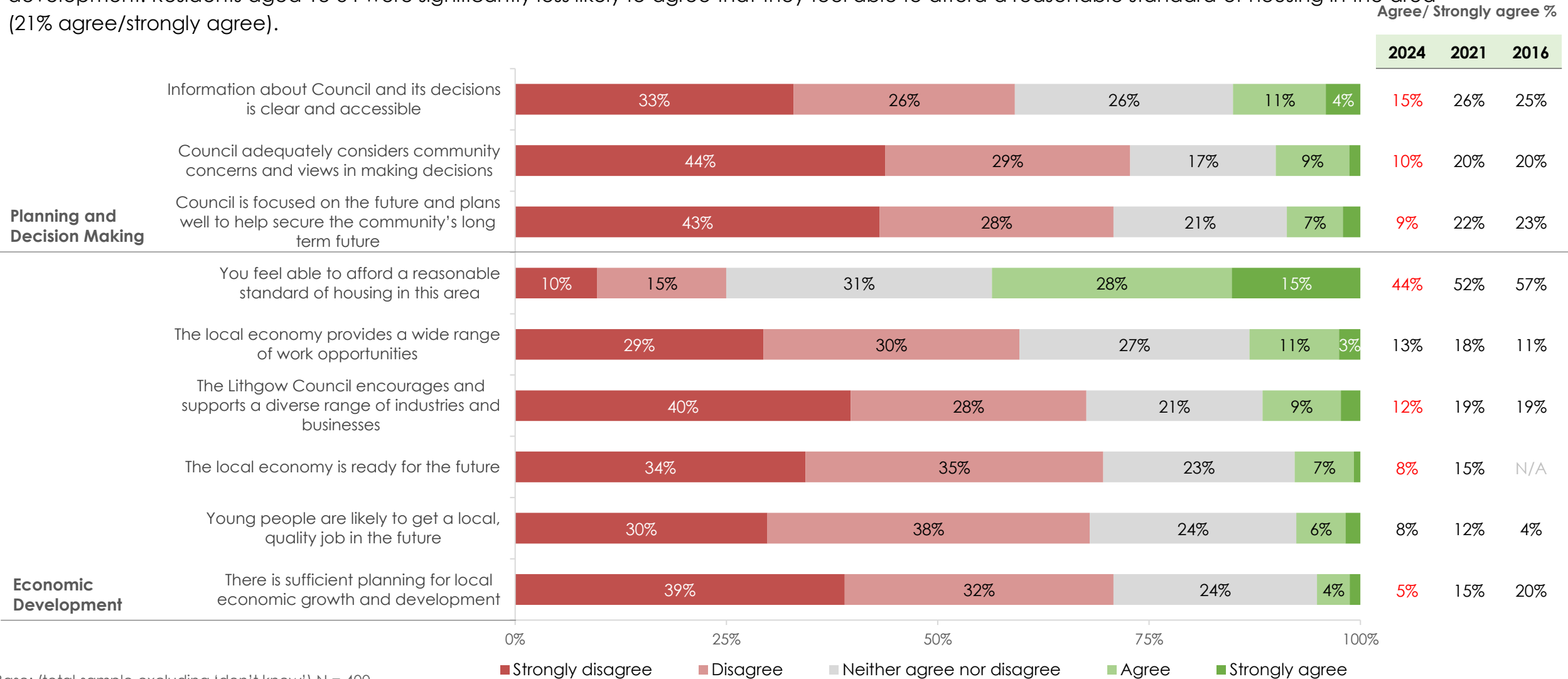

Agreement with Liveability Statements

Very low levels of agreement was seen for planning and decision making and economic development measures. Top 2 box scores of less than 10% was seen for future planning, the local economy ready for the future, young people able to get a local job and sufficient planning for economic growth and development. Residents aged 18-34 were significantly less likely to agree that they feel able to afford a reasonable standard of housing in the area (21% agree/strongly agree).

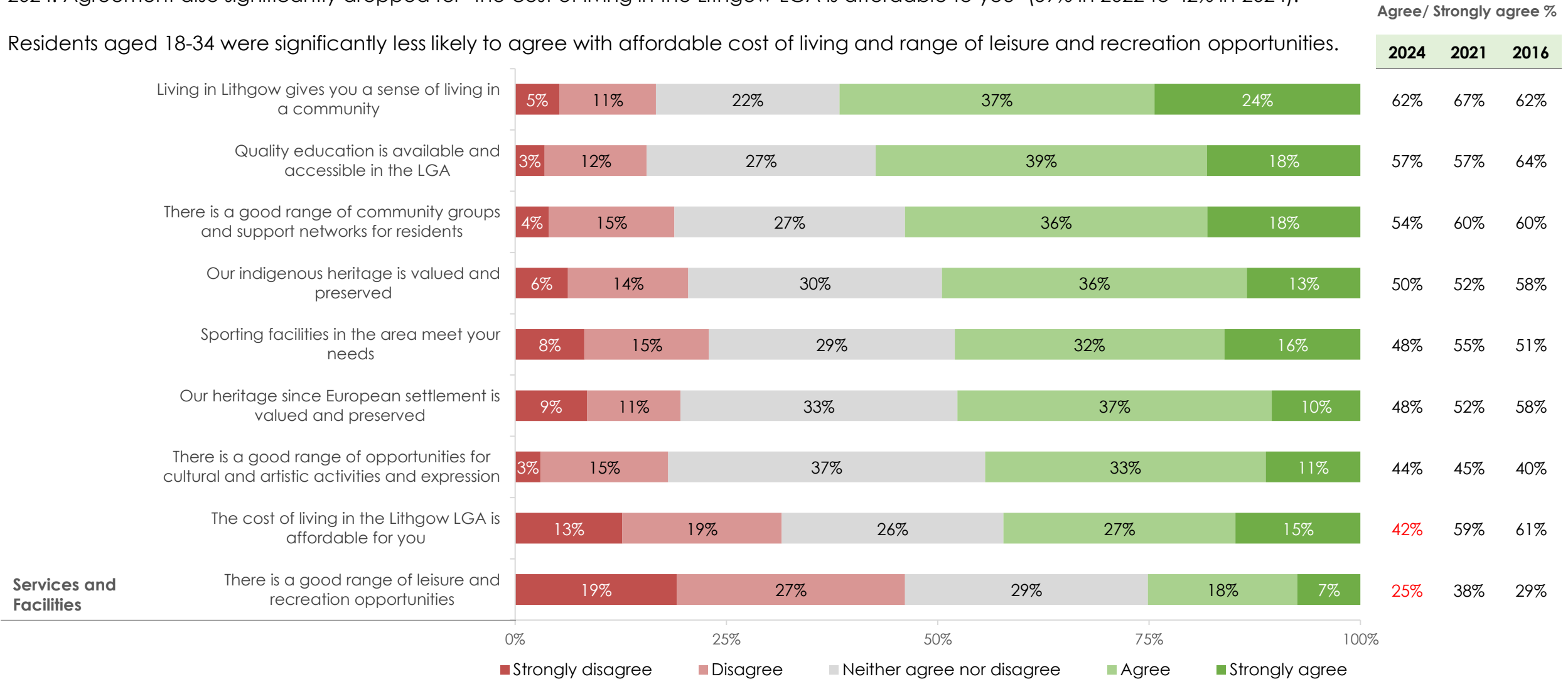

Agreement with Liveability Statements

Within the Services and Facilities pillar, agreement was highest for 'living in Lithgow gives you a sense of living in a community' (62%) and lowest for 'there is a good range of leisure and recreation opportunities' – which has also significantly dropped from 38% T2B to 25% T2B in 2024. Agreement also significantly dropped for 'the cost of living in the Lithgow LGA is affordable to you' (59% in 2022 to 42% in 2024).

Residents aged 18-34 were significantly less likely to agree with affordable cost of living and range of leisure and recreation opportunities.



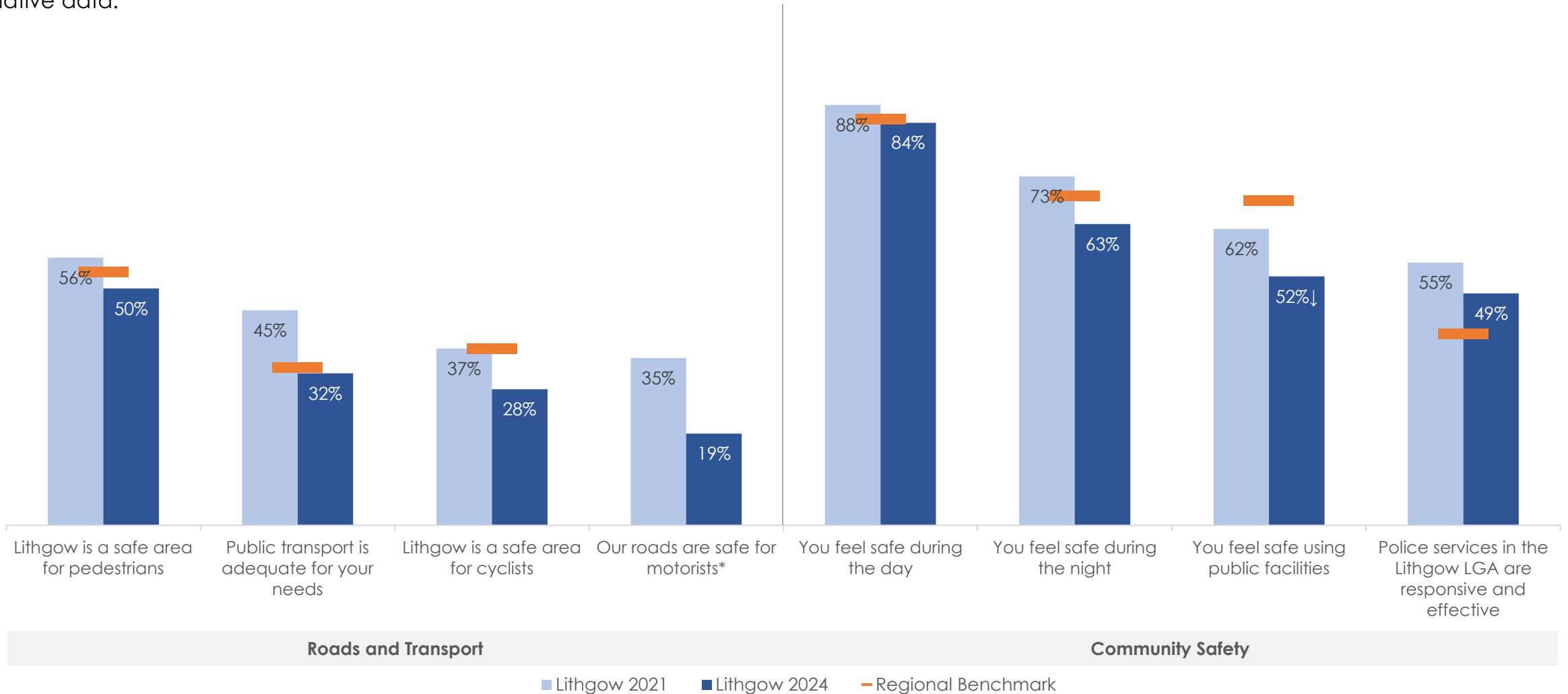

Agreement with Liveability Statements – Benchmark Comparison

The chart below (and continuing over the next 3 slides) show the top 2 box (agree/ strongly agree) scores for 2021, 2024 and the Micromex Regional Benchmark (orange line). Here we can see the results over time, and, how Lithgow City Council's scores compare to other regional councils. With the exception of police services, overall, within the Roads and Transport and Community Safety pillars the 2024 results have dropped from 2021 and are below Micromex normative data.



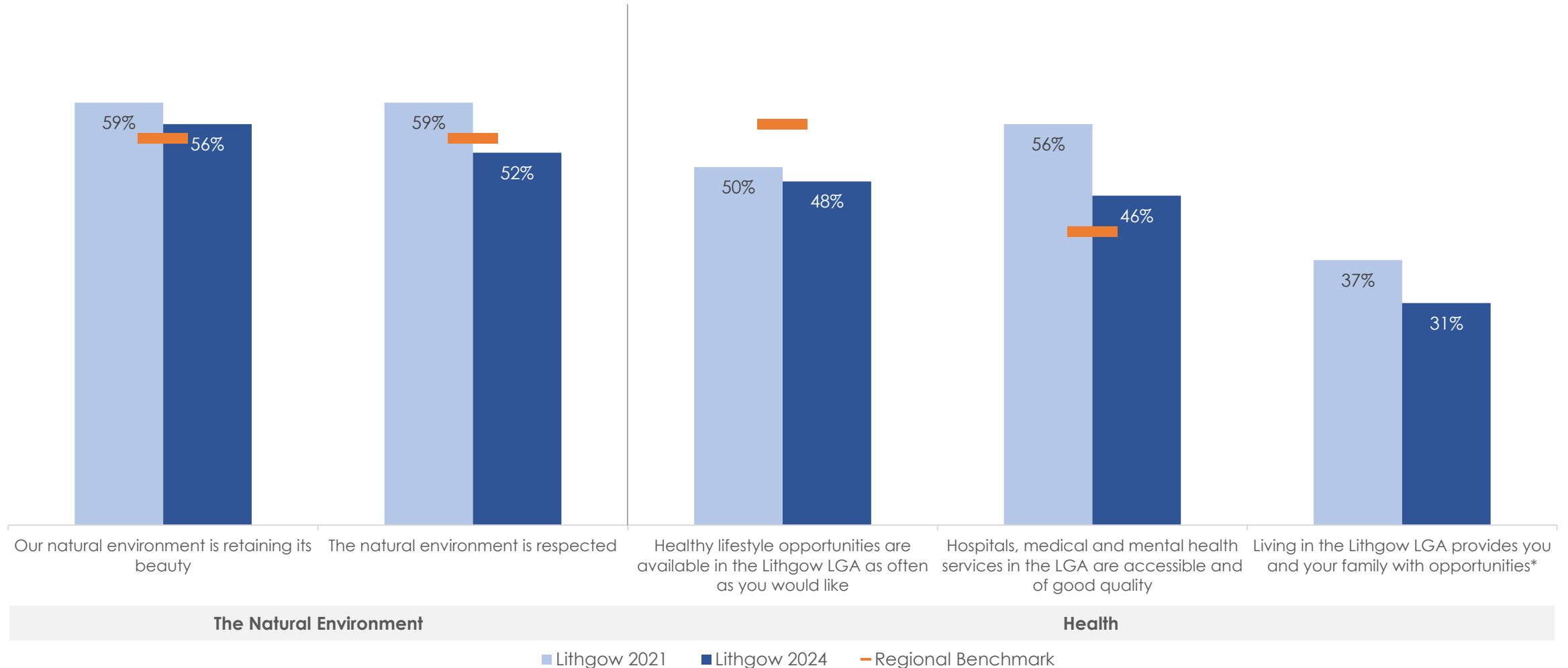

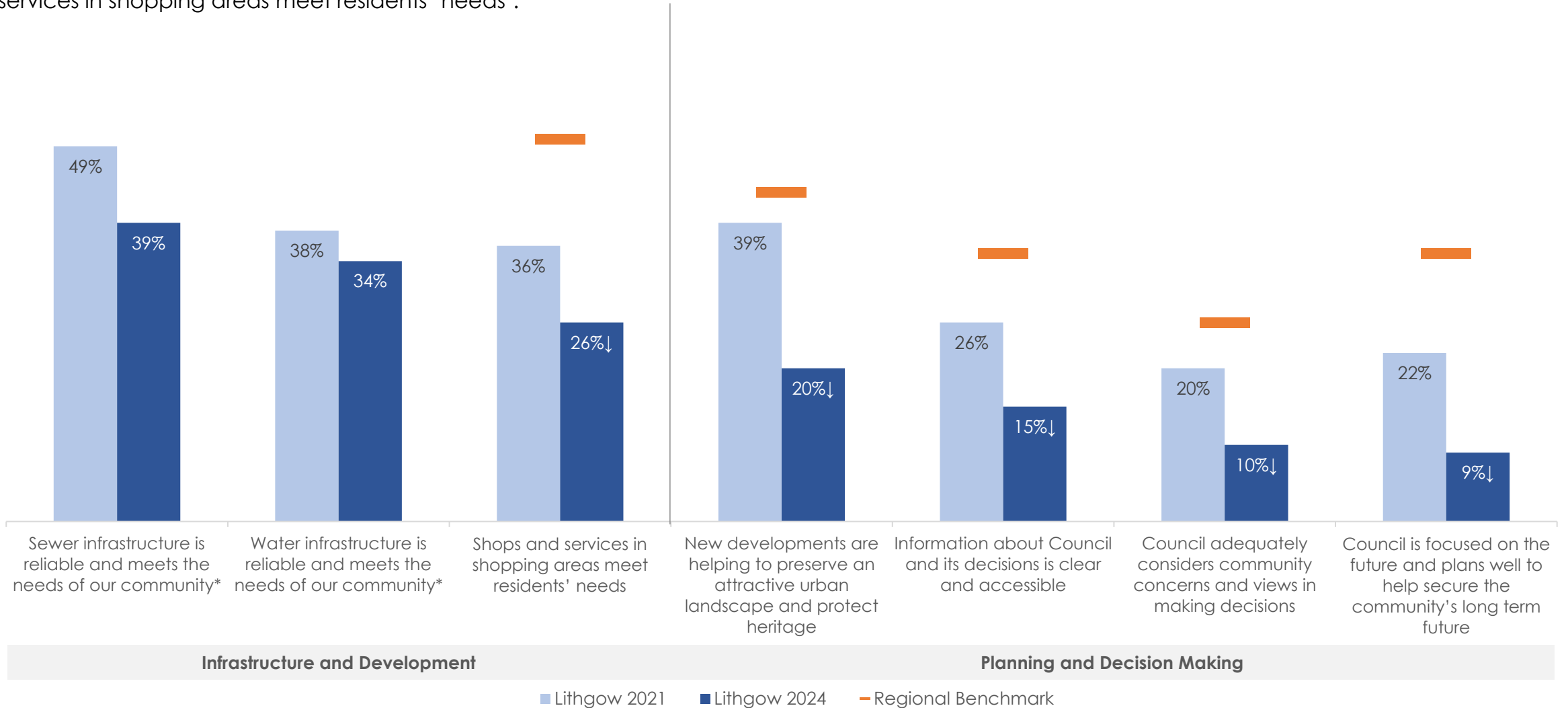

Agreement with Liveability Statements – Benchmark Comparison

Under the Infrastructure and Development, and Planning and Decision Making Pillars, results are significantly below the Micromex Regional Benchmark for all comparable measures. Larger gaps are seen for 'Council is focused on the future and plans well to help secure the community's long-term future' and 'shops and services in shopping areas meet residents' needs'.



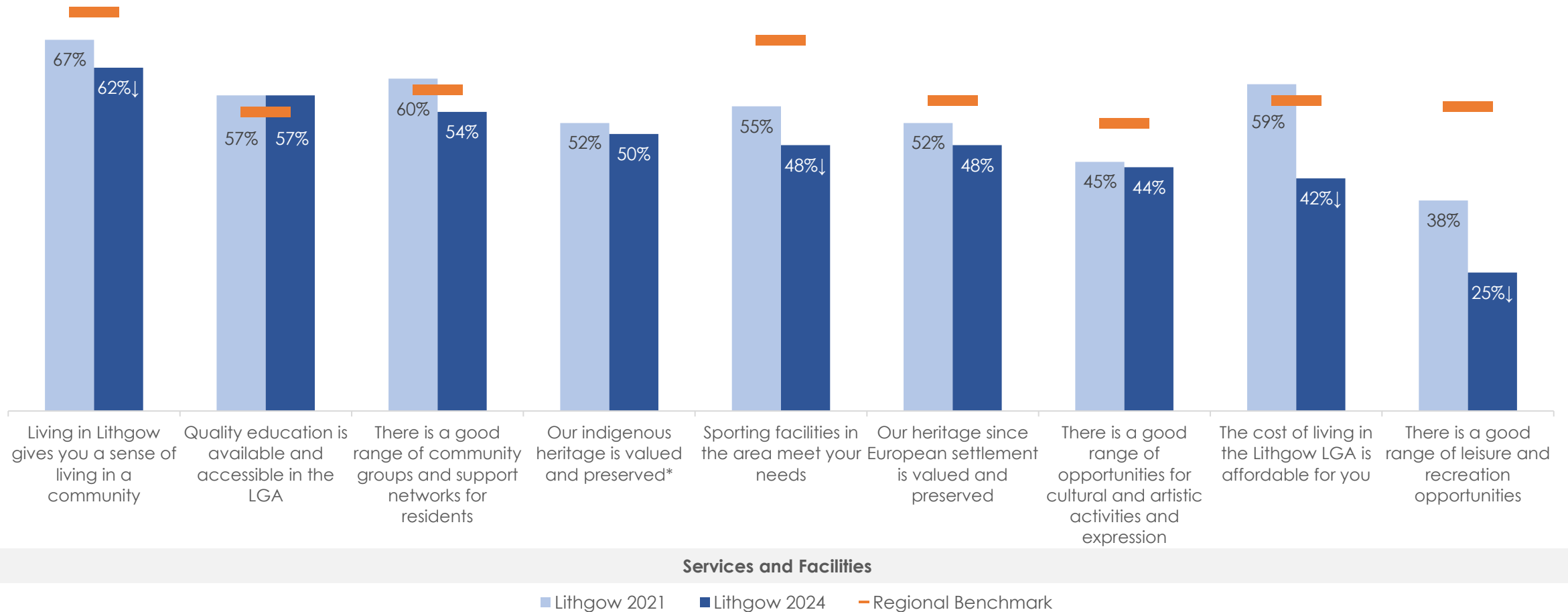

Agreement with Liveability Statements – Benchmark Comparison

Compared to the Micromex Regional Benchmark, results are significantly lower for sporting facilities, cost of living and leisure and recreation opportunities. The gap between the Lithgow City Council T2B score and the Regional Benchmark is greatest, across all 35 measures, for 'there is a good range of leisure and recreation opportunities', with a difference of 30%.

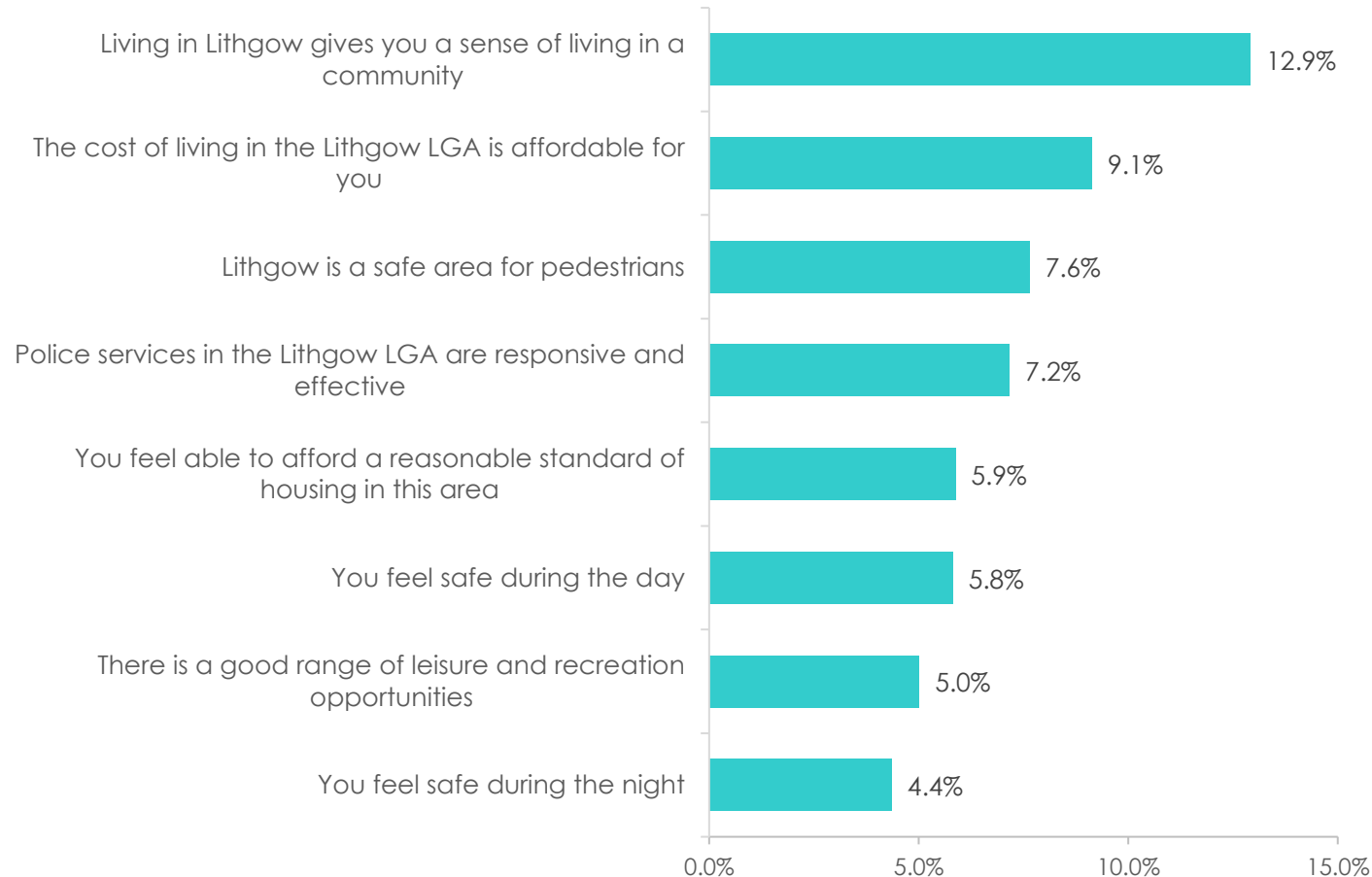

Regression Analysis – Overall Quality of Life

Explanation of Analysis

Regression analysis is a statistical tool for investigating relationships between dependent variables and explanatory variables. Using a regression, a category model was developed. The outcomes demonstrated that increasing resident quality of life by actioning areas of lower agreement would not necessarily positively impact on quality of life.

In the model, the score assigned to each measure is not a measure of agreement/disagreement – rather, it indicates the percentage of influence each measure contributes to overall quality of life. All areas are important – but if Council can increase agreement in key driver areas, they will likely see an improvement in overall quality of life.



These top 8 statements (so 23% of the 35 statements) account for almost 60% of the variation in quality of life.

'Living in Lithgow gives you a sense of living in a community' has the greatest impact, contributing to 13% of the variation in overall quality of life.

Other measures having a greater impact on quality-of-life ratings include affordability (cost of living and affordable housing), safety (pedestrian safety, police services, safety during the day and night) and leisure/ recreation opportunities.

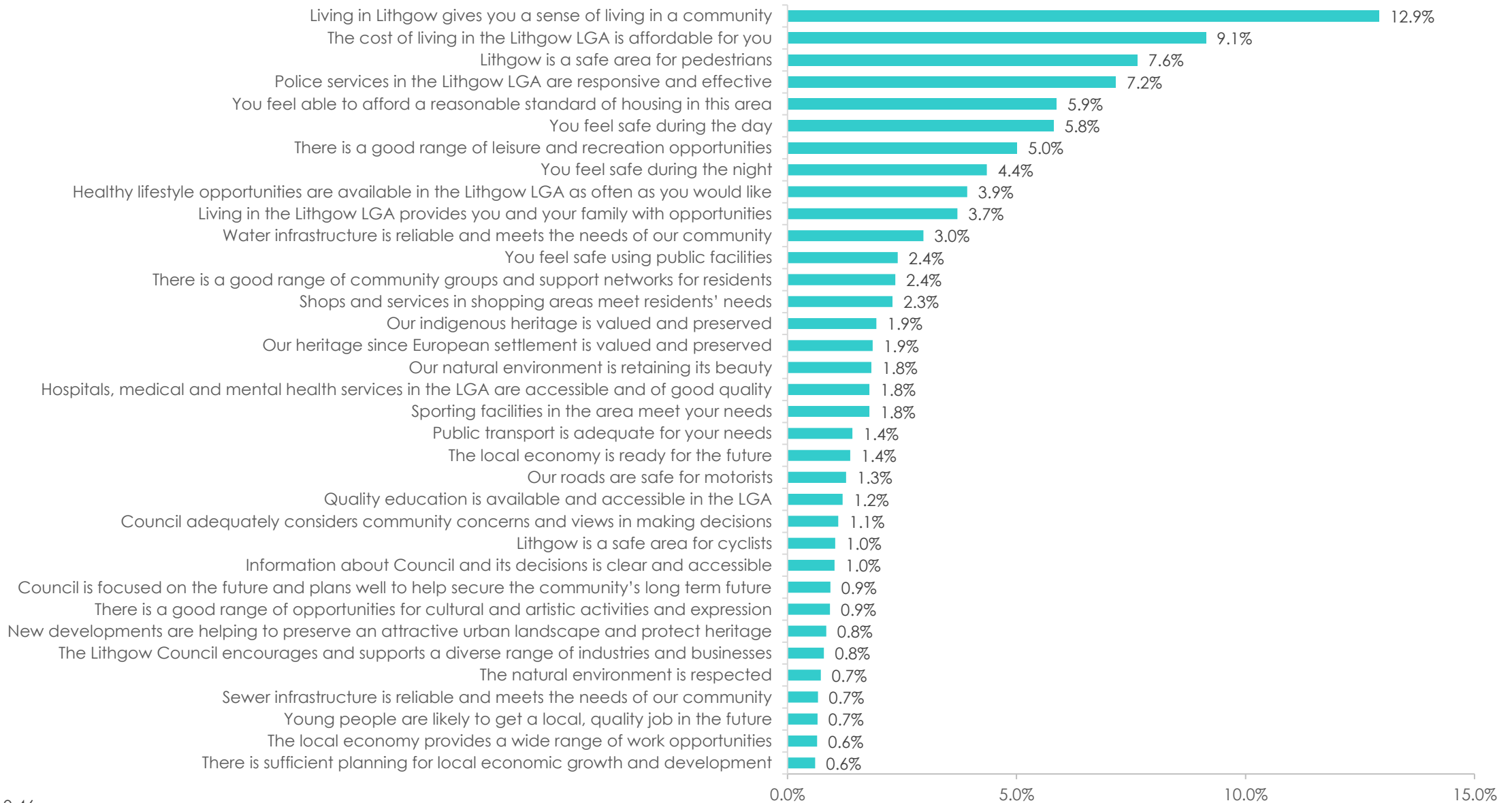

This section explores what residents believe are the highest priority issues for the next 10 years and level of support for projects and initiatives.

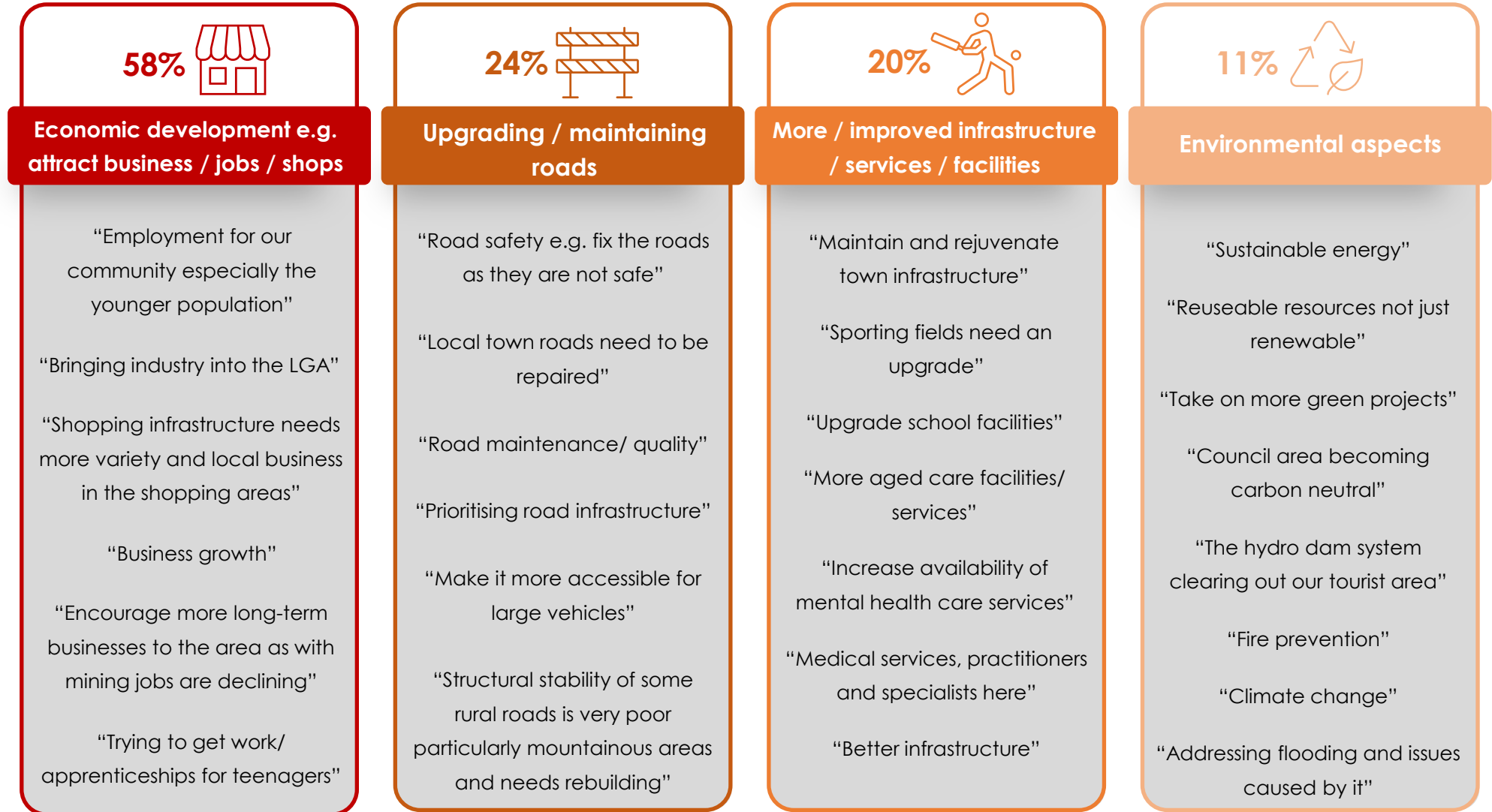
Section Two

Highest Priority Issues for the Community in the Next 10 Years

58% of residents would like to see Council prioritise the economic development of the LGA over the next 10 years, and 24% would like to see roads prioritised.

Other priority areas for residents include the provision of infrastructure/ services/ facilities and environmental considerations such as renewables, environmental protection and natural disaster management.

Highest Priority Issues for the Community in the Next 10 Years

Economic development remains the highest priority area, with more than 50% believing this will be the highest priority area for the next 10 years.

Compared to 2021 significantly more residents prioritised the cost of living/rates and managing growth and development (e.g. retaining residents and ensure adequate infrastructure to match growth).

Q2c. Thinking of the next 10 years, what do you believe will be the highest priority issues for our community?

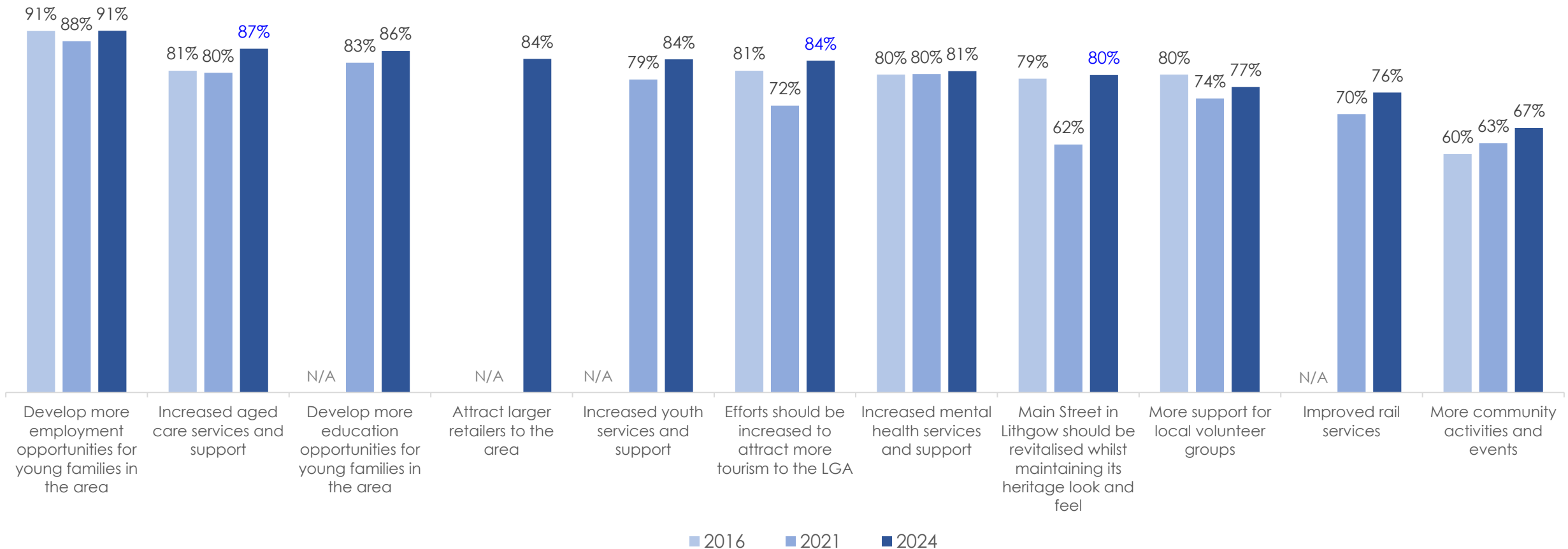

Support for Future Projects and Initiatives

8 of 11 projects and initiatives to be implemented across the LGA received 80% commitment to the top 2 box (being supportive/ very supportive).

Support for all projects and initiatives increased from 2021, significantly so for 'increased aged care services and support', 'efforts should be increased to attract more tourism to the LGA' and 'Main Street in Lithgow should be revitalised whilst maintaining its heritage look and feel'.

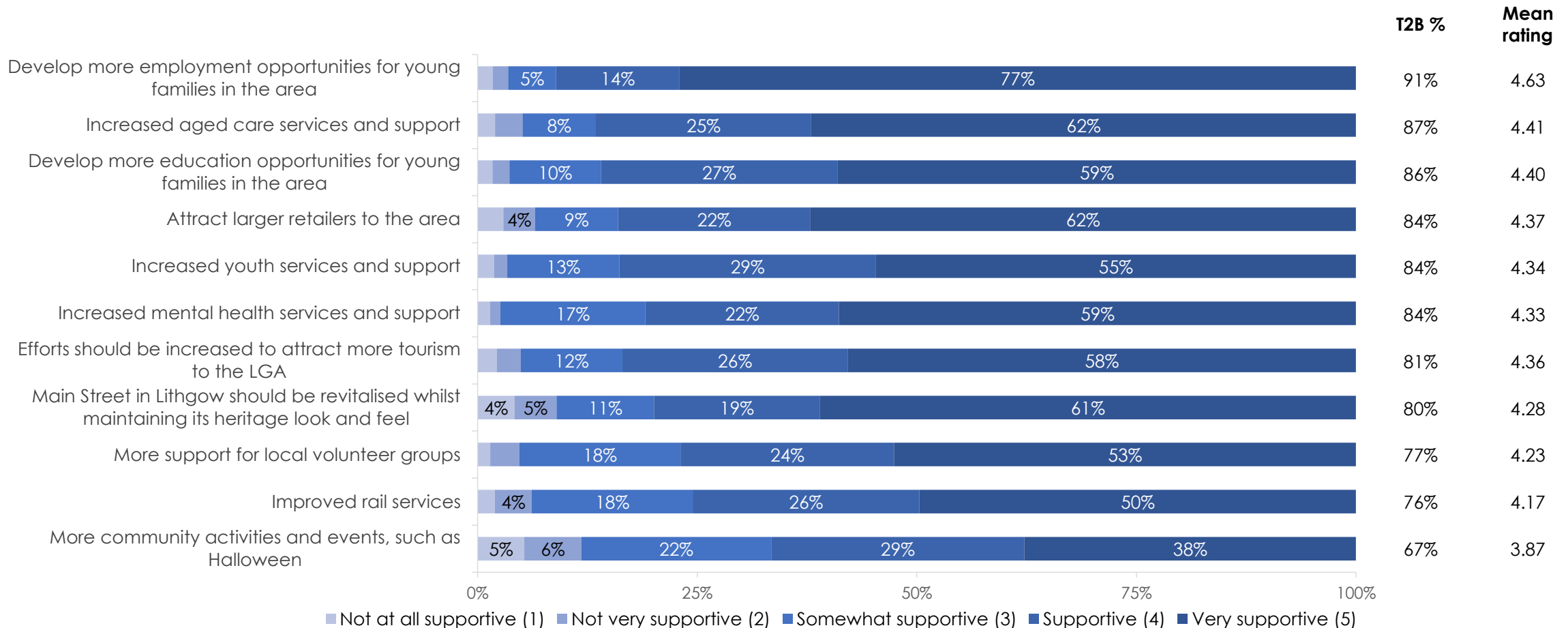

Support for Future Projects and Initiatives

Support is highest overall for developing more employment opportunities for young families in the area, with 91% of residents supportive/very supportive (77% commitment to the top box 'very supportive'), followed by aged care services and education.

Residents aged 18-34 are significantly more supportive of Main Street revitalisation and more community activities and events.

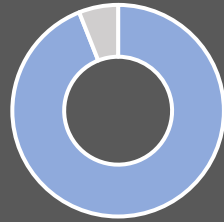
Section Three

Resilience

This section looks at the issues residents have dealt with in the last few years, how concerned they are about future shocks and stresses, how prepared they feel in dealing with these shocks and who they could ask for support in a crisis.



Summary: Resilience



94% of residents feel at least somewhat prepared to respond to shocks and stressors, with 58% feeling prepared/ very prepared.

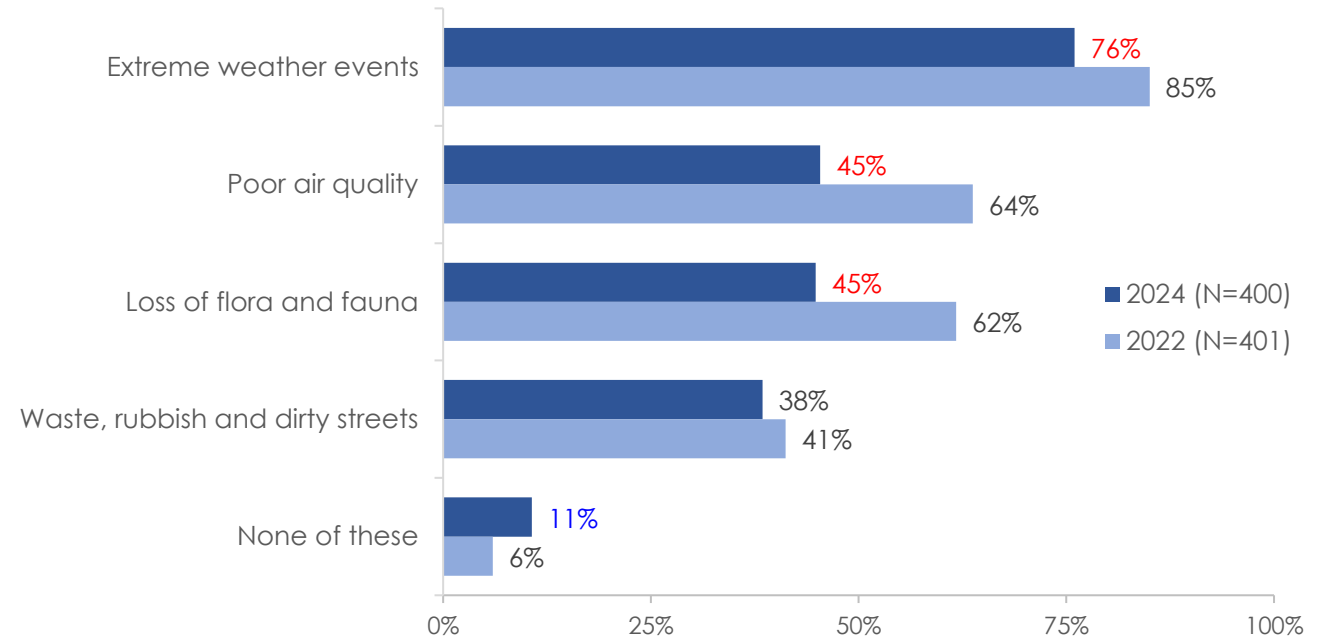
Residents feel most able to seek support in a crisis from a friend, health, medical, legal or professional service and a family member.

 - Bushfires (74%)
 - Lack of electricity (49%)
 - Infrastructure failure (45%)
 - Lack of water (38%)
- Concerned/ very concerned % for **everyday pressures**:
 - Lack of opportunities for young people (82%)
 - Demand on our roads (79%)
 - Demand on our health services (76%)
 - Inadequate investment in critical infrastructure (75%)
- Supportive/ very supportive % for **sustainable recovery projects**:
 - Promoting local employment (92%)
 - Provision of access to clean, safe water (90%)
 - Equity in access to quality education (86%)
 - Improve access to health services and precincts (84%)

Environmental Issues

Positively, significantly fewer residents had experienced environmental issues compared to 2021, however, 76% of residents stated they had experienced extreme weather events in the local area over the last 2 years.

Residents living in Portland were significantly more likely to have experienced poor air quality over the last 2 years compared to other areas.

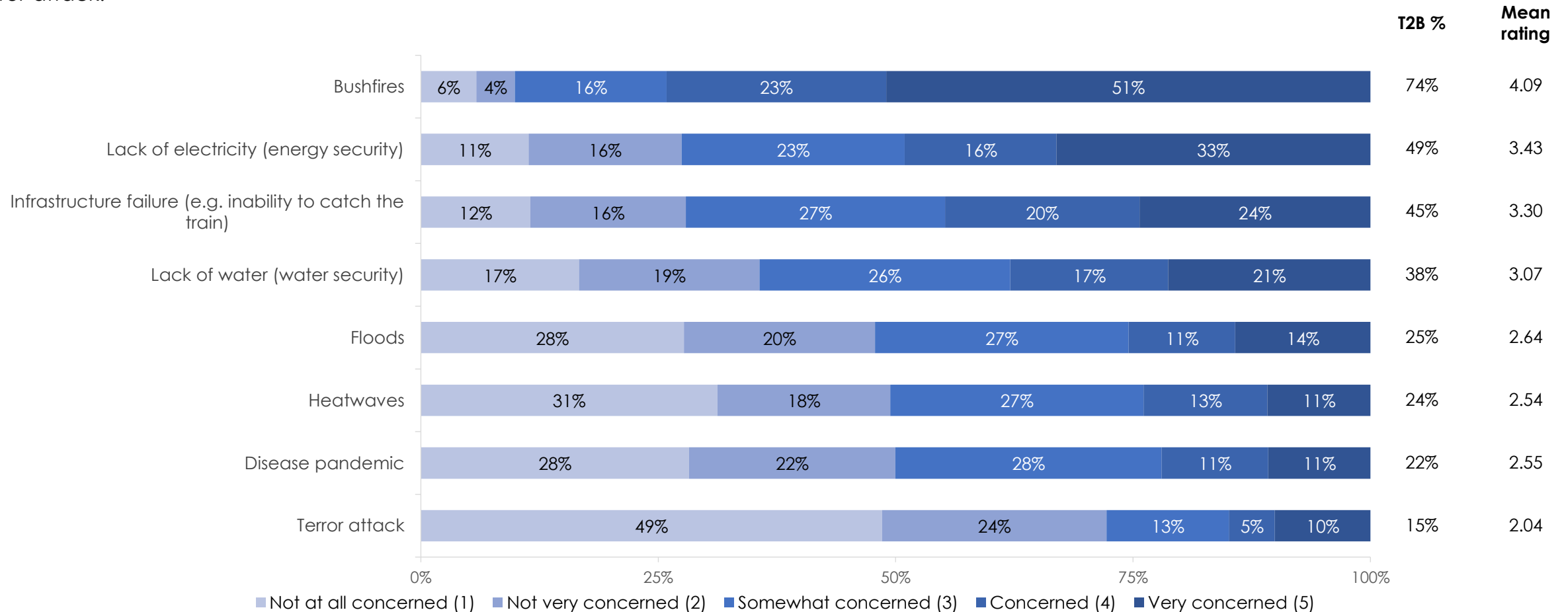

Concern for Short-term / Sudden Events

In terms of short-term or sudden events, Lithgow residents are most concerned about bushfires (74% concerned/ very concerned), followed by lack of electricity (49%) and infrastructure failure (45%). Very low concern for terror attacks.

Older residents are generally more concerned, with those aged 65+ significantly more concerned about a lack of electricity, disease pandemic and a terror attack.

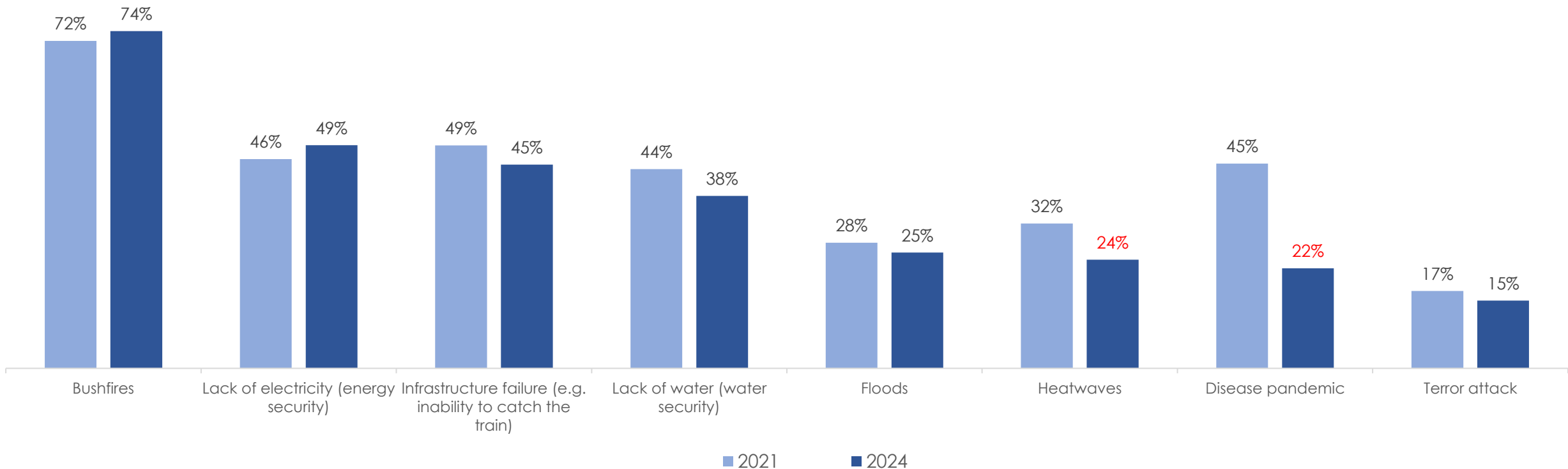

Top 2 Box (concerned/ very concerned) by Year



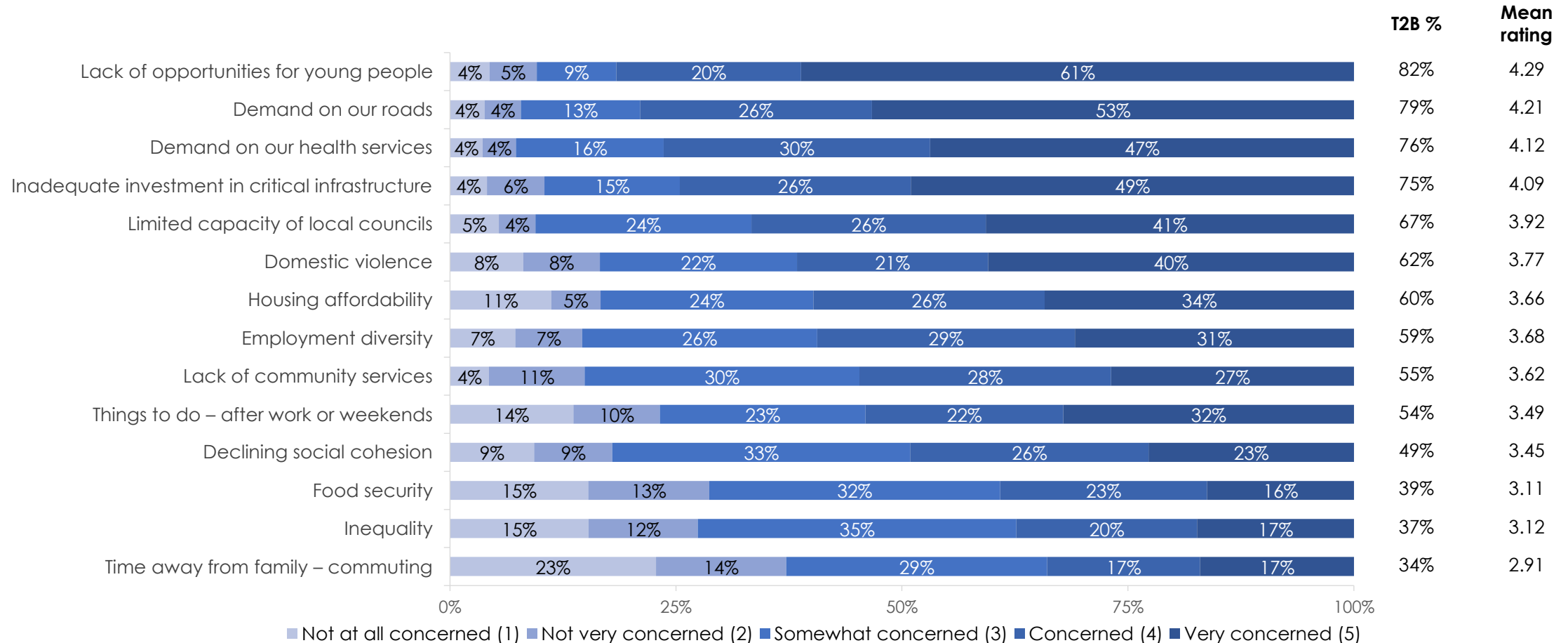

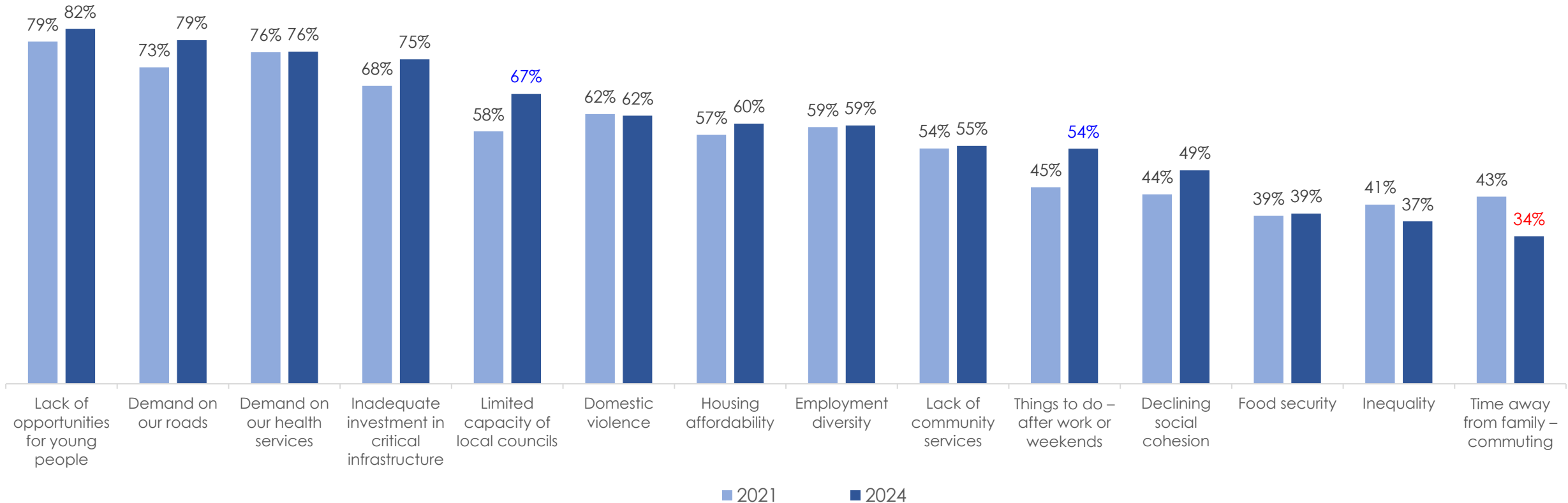

Top 2 Box (concerned/ very concerned) by Year



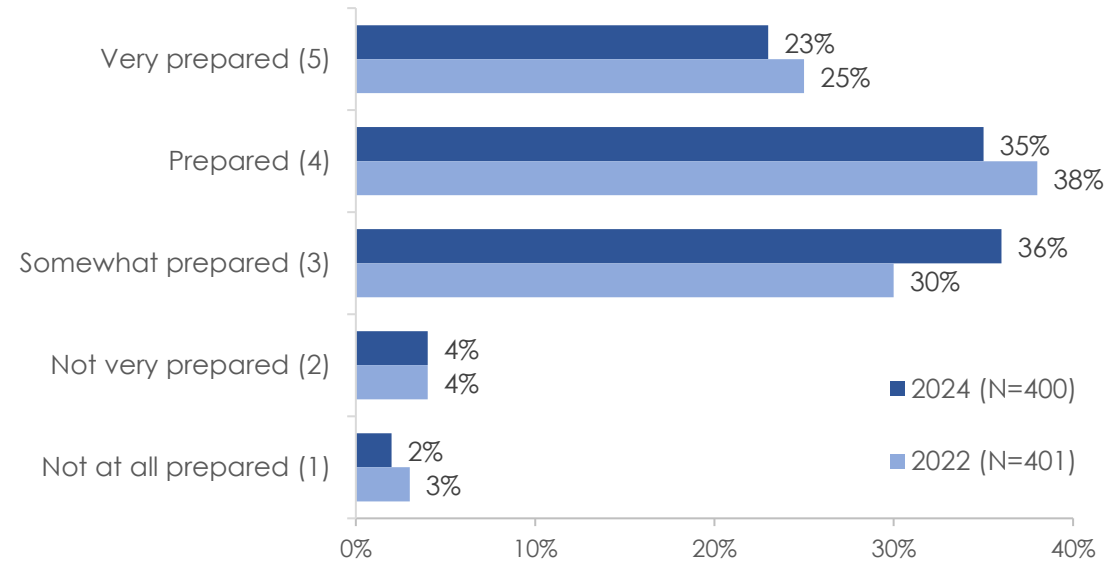

Preparing for Significant Shocks and Stressors

94% of residents feel at least somewhat prepared to respond to shocks and stressors, with 58% feeling prepared/very prepared.

Females and those who identify as living with disability feel significantly less prepared. Although not significant, only 45% of those aged 18-34 stated they feel prepared/very prepared to respond to significant shocks and stressors.

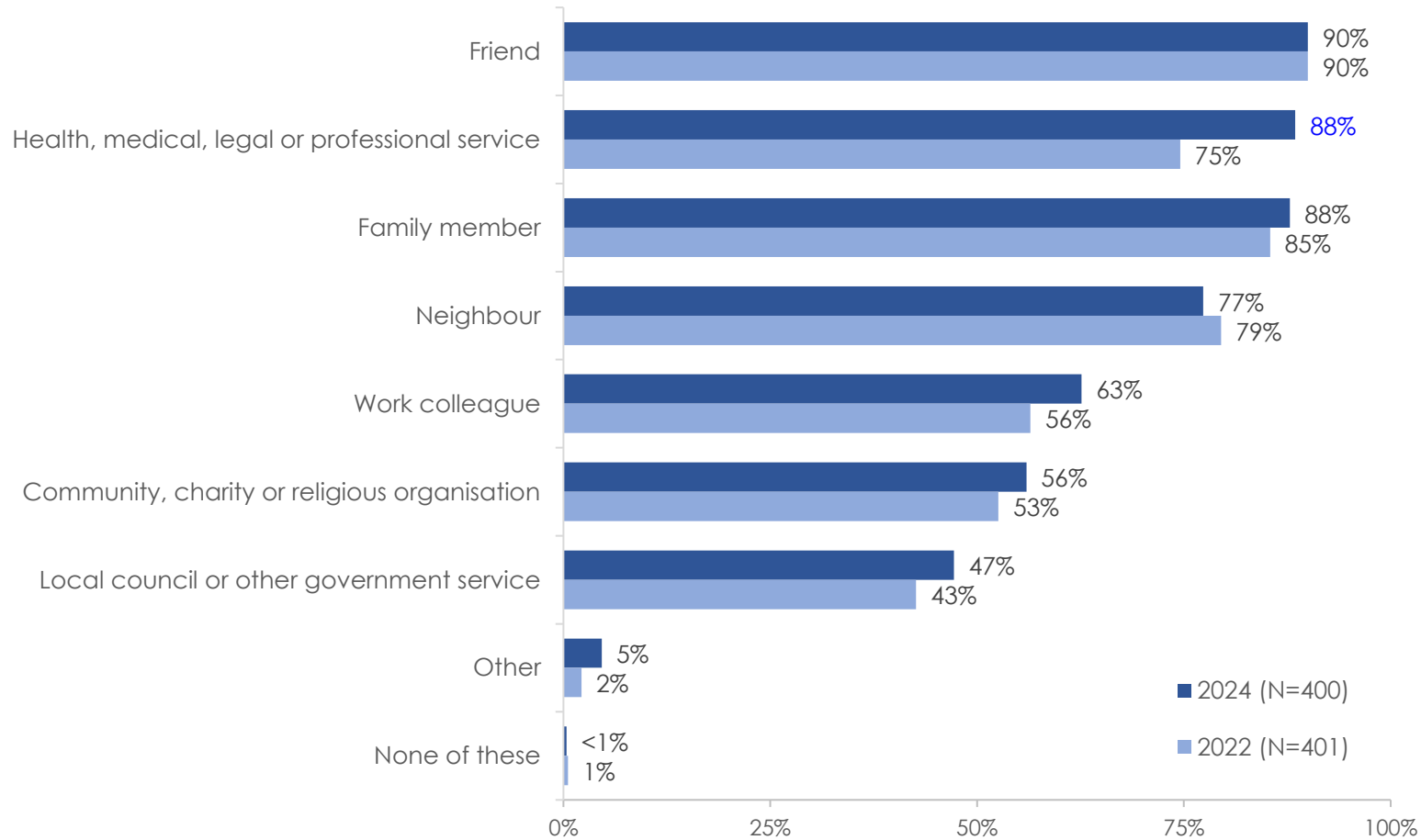

Support in a Crisis

Asking for support from a friend (90%) remains the most common source of assistance, followed by health, medical, legal or professional service (88%) and a family member (88%). Compared to 2021, significantly more residents feel they can ask for support from a health, medical, legal or professional service.

Positively, almost half of residents feel they can seek support from local council or other government service (increasing from 43% to 47%).

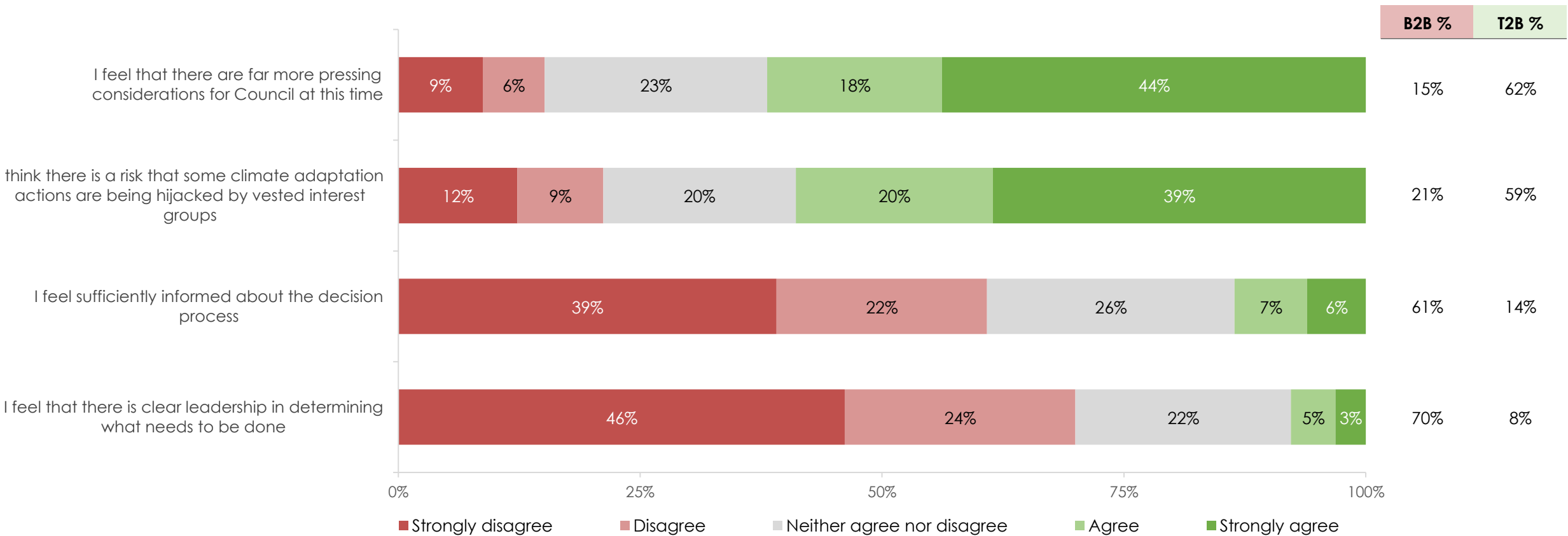

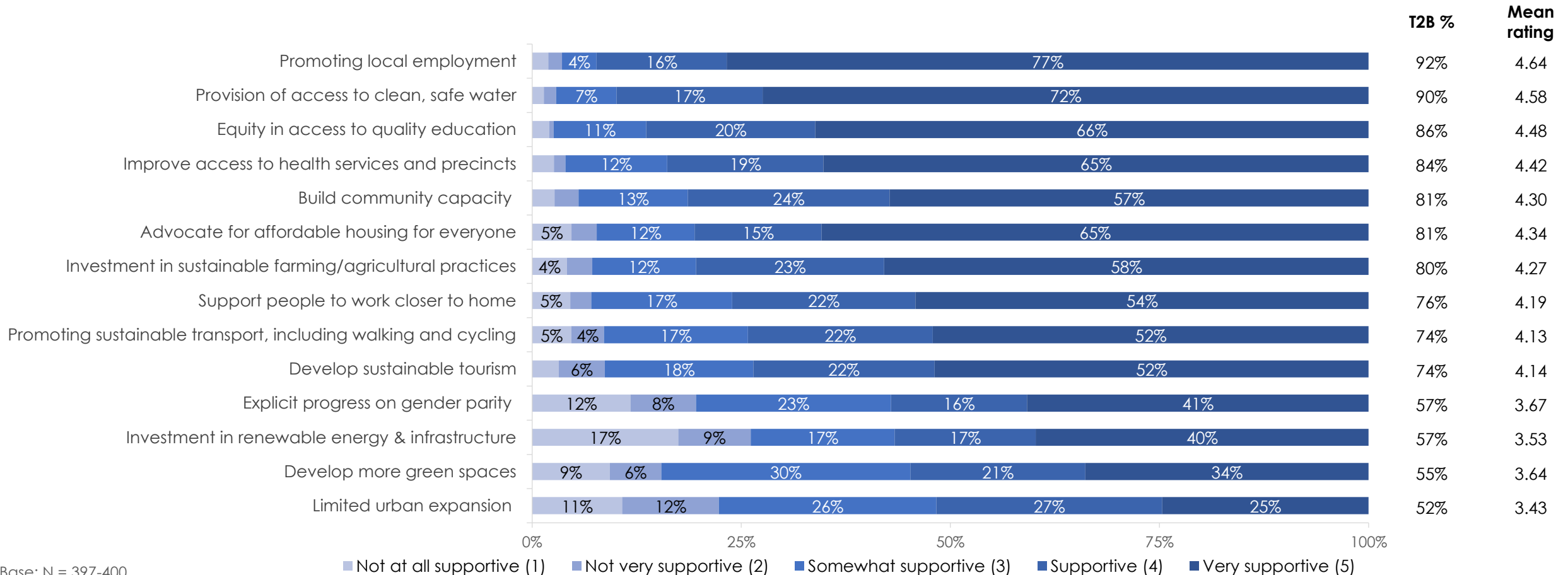

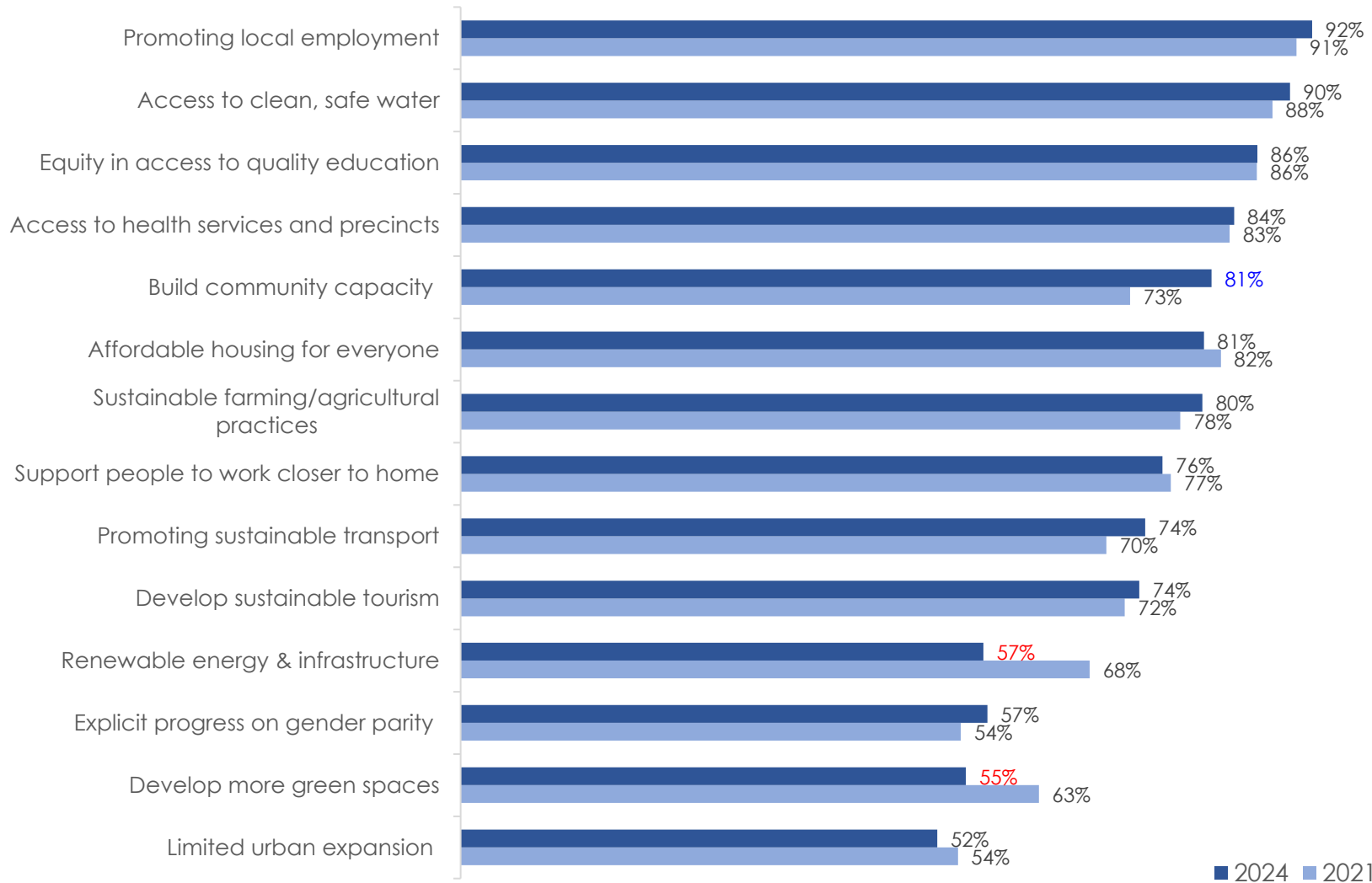
