ITEM: 3 BUSINESS ARISING FROM PREVIOUS MINUTES

3.1. Financial Assistance

Council resolved on 25 March, as recommended by the Committee, to provide \$2,255 Round 2 Non-Recurrent Financial Assistance to Capertee Progress Association for hall improvements and repairs.

3.2 Adventure Playground Signage

The RMS has advised that the only option for installing directional/advisory signage on the Great Western Highway is to apply to TASAC for approval to install white on brown tourism signage. Council's 2018 TASAC application for this signage was rejected in part for the following reason: "The attraction does not appear to have any interpretive materials or marketing collateral as per TASAC requirements. There is no plan or information on how the facility would be marketed or promoted specifically to tourists."

It is now proposed to apply again once interpretative/marketing signage is installed in the park and on Council's Tourism website.
