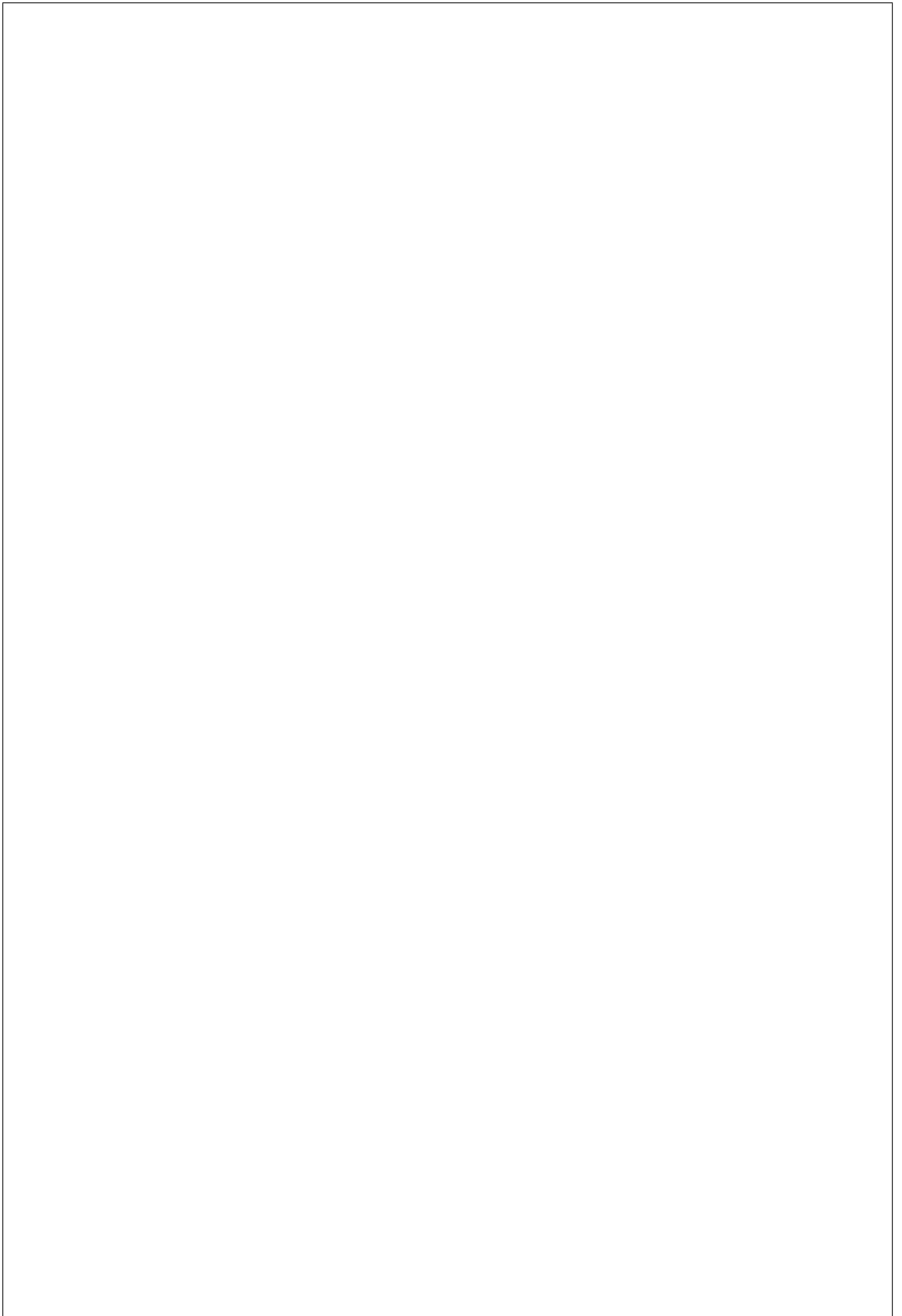

### **6.1. Heavy Vehicle Parking - 1115 Great Western Highway Lithgow**

---

The committee discussed the item. Change of signage requested by the customer would not be effective as the existing signage prohibits the activity from occurring.

Installation of physical barriers would also be ineffective due to the size of the road side area allowing heavy vehicles to double park.

The committee discussed the possibility of Council investigate areas that could be considered for designation for heavy vehicles to park and still have close access to fast food restaurants.

### **ACTION**

THAT the committee note the information provided and Council to investigate an alternate parking area for larger vehicles to bring back to TALC for consideration.

## 6.2. Request for Timed Parking Allocation - 275 Main Street Lithgow

---

The committee discussed the item and believe that the request for short term parking should not be supported due to it creating a precedence throughout the LGA and that there are competing demands for parking at the location. The proposed increase to the no stopping area was supported by the committee as it is a regulatory requirement at the location.

### RECOMMENDATION

THAT

1. Council extend the existing No Stopping Zone on Main Street, at the intersection with Cupro Street, an additional 11 meters and Neighbouring properties be notified of the proposed changes.

## 6.3. Traffic Signage - Flint McClelland Drive, Landa Street and Ninda Place Lithgow

The committee discussed , that while not technically required it would eliminate any ambiguity regarding priority at the intersection. Signage on Ninda Place was not considered necessary as it is a private driveway.

**THAT** Council install a give way sign and a holding line on Flint McClelland Drive at the intersection with Landa Street

## 6.4. Zoo 2 Zoo - Sydney to Dubbo Bike Event

## RECOMMENDATION

**THAT** Council approve the Zoo2Zoo 2019 bike riding event on Lithgow Council managed roads, pending the submission of additional information and implementation of conditions:

- Installation of static signage one week prior to the event on LCC Roads, informing of the event details to the general public
- Confirmation of the support vehicles role and numbers , noting that lead and tail vehicles cannot be support vehicles
- Amend the Traffic management plan to include 2 tail vehicles
- Clarify the distance between individual groups to ensure that the general public have space to manoeuvre around the groups of cyclists.

### 6.5. Event - Bowenfels Station 150th Anniversary Event

**6.7. LATE ITEM - Barton Ave - Parking Signage**

J Edgecombe raised the concern of parking along Barton Avenue Wallerawang in front of the school. It was noted that there is a no stopping sign at the halfway point of the concrete footpath on the left hand side. Parents/ Caregivers are parking in a narrow section between the footpath and the fog line. Parking in this area could cause an accident.

The committee discussed adding additional no stopping signage to deter parking in a narrow area.

**RECOMMENDATION**

THAT Council install no stopping signage along Barton Avenue towards the end of the footpath and notify the school of the proposed changes.
