To the General Manager,

I am in favour for off leash dog parks, as the parks are a great way to socialise dog in a safe environment. But I feel before council goes ahead with a new off leash dog park council needs to upgrade existing off leash dog parks.

My dog and myself attend Endeavour dog park nearly every day and the only maintenance at dog park besides mowing of grass and emptying bins has been cement slabs at gates and water bucket as well as double gating, which I submitted a letter ( never had any correspondence back ) and continually ring and went into council to make the double gating to happen.

Since the opening of the children's adventure park at Endeavour park there has been an increase of dogs at the park. People traveling through Lithgow call into the park to let their dog have a run and toilet break.

The park looks very sad sitting besides the children's playground. The dog park is certainly overdue for maintenance. The park is a dust bowl in the dry weather and when it rains a mud pit. The drinking bowl is a bucket which was brought to the park by one of the regular people who bring their dogs to the park. There are holes in the fencing. The only seating in the park is a seat that is in the sun which can't be used in summer time. I was told that council would put more seating in, but that has not happened.

I just ask council to have a look at the existing dog parks and do some upgrades that have been well overdue before going ahead with another dog park.

The Endeavour Park isn't maintained and my dog has cut her paws multiple times due to the state of the grounds. With multiple visits to the vet. I'm not the only dog owner who had to take their dog to the vet due to lack of maintenance.

There are three or four dog water taps in the park adjacent to the off leash dog park which would be better utilised if the off leash area included the whole park. The one tap in the dog park area has no drain and so causes a waste of water and muddy holes.

This park is often used by passers by and it would be nice if it was up to standard with the facilities already in place in the adjacent park.

In my opinion money would be better spent upgrading the parks we already have.
