

# 6. LJ Hooker Reg Cowden Memorial Sports Star of the Year Awards

# 6.1. LJ Hooker Reg Cowden Memorial Sports Star of the Year Awards

#### **SUMMARY**

There were no written Junior nominations for the month of October & November 2019 received.

Senior nominations for the month of *October 2019* were received from:

- Tracey Baker (Hockey) Tracy represented NSW Masters Hockey at the Australian Masters Tournament over 55's team held on the Gold Coast over 12 days. In the round games: tied with QLD No 1, QLD No 2, VIC, WA, and defeated ACT 1 –0. NSW was undefeated at the finish. In the final, played QLD No 1 with full time score 1-1. This called for 5 players competing in a 1-1 with the goalkeeper, 8 seconds each player. Unfortunately, NSW went down 3-2 and won the silver medal. This was Tracey's 1st year representing NSW Masters.
- Cheryl Rutherford (Hockey) Cheryl represented NSW Masters Hockey at the Australian Masters Tournament, over 60's team held on the Gold Coast over 12 days. In the round games: Lost to QLD No 1 by 0-2, defeated SA 5-0; drew with WA 2-0; drew with VIC 2-0, Defeated QLD No2 by 6-0. NSW was placed 3<sup>rd</sup> overall and played 2<sup>nd</sup> place QLD in the semi- final, taking the match 2-1 to put them in the final. In the final, played VIC accounting for them 3-2 and won the championship, taking home the gold medal. Cheryl played in the "Striker" position, won a converted penalty stroke and set up many of the team's goals. From this tournament, Cheryl gained selection ion the Australian over 60's team to compete in South Africa. This is also Cheryl's 18<sup>th</sup> year representing in the NSW Masters. NSW 60's won the 'Play the Whistle' award. This is judged by the technical bench and awarded to the team which shows great sportsmanship over the tournament.

There were no written Senior nominations for the month of November 2019 received.

R Marjoram raised the idea of introducing a new category ie. creative art. The committee discussed this and agreed that creative arts ( Dancing & Physical Culture) is considered a sport and no other category is required and juniors and seniors in these sports are eligible to be nominated for the monthly/ yearly Reg Cowden Awards.

As there were no Junior nominations for the month of October and November 2019, nominations were accepted from the floor.

Letti Seymour - Physical Culture was nominated for the October monthly award Eli Morris - Cricket was nominated for the November monthly award

There were 2 nominations received for senior monthly award for October. The Committee agreed that Tracey should receive the October award and that Cheryl should receive the November award.

### **Pool Parking Area & Aquatic Centre**

P Evans asked if there were any plans in place to seal the car park area between the Pool and the Showground as there is currently a large dip when parking in the area.
