Council has engaged a consultant to assist with the development of the Comprehensive DCP, which will contain a Heritage Chapter developed from the work reviewed by the Committee previously.

Heritage Grants Program

Lithgow Pottery and Brickworks

Lithgow Valley Colliery Company - CMP

Council has approved a business case submitted by the Cultural Development Officer for funds to deliver a Conservation Management Plan for the historic pottery site.

This seeks to develop recommendations for the protection and interpretation of remaining historical structures and archaeological footprint.

The CMP will need to be delivered between July – October 2020 in order to be a critical component of a submission to the Office of Environment and Heritage in early November.

This project will require the support of the Heritage Committee in contributing research material in order to meet the tight turn around. The Heritage Advisor has visited the site with the Cultural Development Officer to make recommendations for minor works in order to protect the site in the interim period. These consist of removal of surrounding tree roots, ivy, and any vegetation impacting mortar or structural stability; lawns maintained on a scheduled basis; pegging out site. These minor works will assist in making the site safe and protect historic fabric, but are however, dependent on current available financial resources.

Update

A verbal update report was provided by Council's Cultural Development Officer – S Hipworth

- Council has allocated funding for the preparation of the Conservation Management Plan. A professional services brief has been prepared and a procurement process through Vendor Panel will be undertaken shortly.
- No consultation with adjoining owners has occurred to date to assess willingness to partner in the project.

Heritage TASAC Signage

Council still needs to update some inventory sheets from information we obtained during the LEP consultations rounds as well as entering in further details of new inventory sheets that were produced to enable listing of some 10 or so further items the Office of Heritage does not have. These will have limited information in the OEH database site and therefore it will be necessary for the community to continue contacting Council for these items until such time as they are updated within that system.

Recommendation/Action:

- Council to make enquiries with Transport for NSW in relation to any detailed designs for the Great Western Highway Upgrade in the vicinity of Little Hartley to assess its impact on listed heritage items.
- 2. Request Council officers to report to the Committee in relation to a proposal for Heritage Recognition Awards.
