9. General Business

D Whitty raised concerns that the Sports Advisory Committee may no longer exist and sought clarification on the matter. J Edgecombe confirmed that Council is currently reviewing all Council committee to see if they are achieving goals and relevance to the Council & the community. It was advised that any changes to the committees , the members will be consulted.

Representatives from the Lithgow District Football association requested a letter of support to apply for funding through football NSW for upgrades to the amenities at the Marjorie Jackson Oval. J Edgecombe confirmed that Council would be happy to support and to forward a request into Council by way of letter or email.

T Crook advised that the nets at Watsford Oval are beginning to wear through , and wanted to give notice to consider in the budget for repair works. The administration taken this onboard and will be considered.

J Kemp advised that committee that the Football Association will be looking to hold a FFA games and asked that if they had a chance at playing at night time would they be able to hold at the Tony Luchetti but wanted to confirm the LUX reading of the lights. The administration could not confirm the LUX of the lights but noted they were not to a professional standard. The administration also confirmed that Council will continue to seek grants for further upgrades to sporting facilities through state and federal funding as we have done previously for the refurbished change rooms and irrigation at Tony Luchetti.

The administration requested that field one at the Tony Luchetti be used only for ball work with previous arrangement with Workies and Bears to share.

Clr J Smith requested that any association with keys for any Council facilities must report to the administration what keys they have. Administration confirmed that the register will be sent around. It was also noted that Cricket can access the covers for the pitches by contacting Council.
