## 6. Staff Reports

## 6.1. Old Bindo Road - Temporary Changes to Road Weight & Speed Limit

The committee reviewed the report.

The Director Infrastructure Services advised of two main issues in the area being:

- The Old Bindo Road is used as a detour route when the Jenolan Caves Road is closed;
   and
- The area is a popular tourist spot when there is large snowfall in the area.

It was noted that these recommended changes are more of a preventative measure as the road is not designed for high volume of vehicles or large amount of heavy vehicles.

The Director Infrastructure Services advised that Council may need to approach Forestry about the change in load limit.

W Hazelton advised that from a Transport NSW perspective there is no issues with the weight limit however agreed with discussing with Forestry as Clr D Goodwin raised that part of the road is owned / controlled by Forestry. Council will be able to place a load limit on their section however may cause issues with Forestry Corporation. The NSW Speed Zoning Guidelines are currently under review. At this point, speed zones, other than the default, are not applied to unsealed roads.

Clr D Goodwin advised that the speed limit would be good for the area.

It was agreed by the committee that the Forestry should be involved in this process.

#### Original Recommendation

Council make a formal application to TfNSW to reduce the speed limit on Old Bindo Road, Hampton from 80km/h to 50km/h and impose a 5 Tonne load limit to improve safety and ensure safe road surface condition

#### **Col's Comment**

Residents reported an increase in heavy vehicles and general motorists shortly after the closure of a section of Jenolan Caves Road.

- -Old Bindo Road leads into the Forest, I cannot see it being used as any sort of by pass for Jenolan Caves rd. Unless they are suggesting the forestry workers and machinery are accessing the forest through Old Bindo Road instead of Duckmaloi Rd. Which they would be allowed to do even if the load limit is reduced to 5 t.
- -Should we investigate the alleged increase in traffic volume (especially the heavy vehicles) further before changing the speed limit and weight limit. Because once it is changed the residents will want it enforced.
- -It is an unsealed road and would not be patrolled by HWP for speed enforcement or weight restrictions. If vehicles over 5 t are required to enter due to working/living/delivering in that area, they the weight limit doesn't apply.
- -There is no crash history for that Road in the last 5 years.

If we make that unsealed road 50 are we going to look at all unsealed roads. I could be incorrect but I was of the opinion that RMS don't classify unsealed roads.

# I'm not supportive, as it creates other issues that may need to be addressed later.

#### **THAT**

- 1. Council make contact with Forestry Corporation in relation to the matter of Load Limits on the Old Bindo Road; and
- 2. That a report be brought back to the TALC Committee after contact with Forestry Corporation; and
- 3. Council make a formal application to TfNSW to reduce the speed limit on Old Bindo Road from 80km/h to 50km/h
